May kindly see the letters dated 31-07-12 placed below at flag 'A', received from Sri Jitendra Singh-II, Additional Civil Judge (Jr. Div.), Budaun regarding submission of statement of movable property exceeding to value of one month's basic pay and immovable properties acquired/held by his or any member of his family for the financial year 2010-11 & 2011-12 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection it is submitted that from perusal of the aforesaid property statement it appears the in the financial year 2010-11 Sri Jitendra Singh's total income (from salary and other resources) was Rs.09,14,684, from this amount his deductions was Rs.87,866/-, deposited Rs.87,215/- (including interest) in various Bank Accounts, and Rs 56,170/- deposited in premium of LIC policies. Total deductions and investment is Rs. 02,31,311/- Thus a sum of Rs. 6,83,373/- was therefore available to him to meet out his family (three members) expenditure in whole financial year.

In this connection it is submitted that from perusal of the aforesaid property statement it appears the in the financial year 2011-12 Sri Jitendra Singh's total income (from salary and other resources) was Rs.08,19,161/- from this amount his deductions was Rs.48,900/-, deposited Rs.1,45,837/- (including interest) in various Bank Accounts, Rs 56,170/- deposited in premium of LIC policies, Rs. 2,25,000/- he purchased N.S.C. from the arear of Shetty Commission and Rs. 1,80,000/- paid house loan. Total deductions and investment is Rs. 06,55,907/- Thus a sum of Rs. 1,63,254/- was therefore available to him to meet out his family (three members) expenditure in whole financial year.

Sri Jitendra Singh has purchased a house no. 84 B, Space Valika, Phase-II, N.H.-2, Sikandara, Agra measuring 1650 Sq. feet from Gee Diamond Steels Pvt. Ltd. For Rs. 16,50,000/- for which he has taken loan of Rs. 14,21,000/- from SBI, Atrauli, Rs. 2,29,000/- taken from his father (retd. District Judge) and rest amount paid from his salary SB A/C no. 10896572519. Information of which has already send by the officer (flagged 'L').

In this connection it is submitted that Sri Jitendra Singh has already submitted his property statement up to financial years 2009-10 which has already been seen by Hon'ble Mr. Justice Shashi Kant Gupta, the then Administrative Judge, Saharanpur on

02-06-2011 at flag 'Z'. The said property statement for the financial year 2009-10 is at flag 'M'.

The instant statement submitted by the officer for the financial years 2010-11 & 2011-12 through his letter dated 31-07-2012 (flagged 'A') which was due to be submitted in third financial year accordingly i.e. 2012-13, which was end up on 31-03-2013. As such there is no delay from the part of officer in submitting the statement.
