May kindly see the letter dated 11.9.14 (at flag 'A') of Sri Jitendra Singh, Judicial Magistrate, Budaun by which he has submitted his property statement for the financial years 2012-13 and 2013-14.

In this connection, it is submitted that as per statement of movable and immovable property for the financial years 2012-13 and 2013-14 of the officer concerned, details of income, deductions, Savings, investment and expenditure made by him are given below:-

(1) In the financial year 2012-13, Sri Singh's annual income from salary and other Sources is Rs.8,80,581/- from this amount, he has paid Rs.4800/- against GIS, Rs.71,379/- against Income Tax, Rs.46,998/- (with interest), against PPF, Rs.56,170/- against LIC, Rs.21,900/- against NSC, Rs.1,80,000/- against Home loan installments. As such, total deductions /Savings/investment is Rs.3,81,247/-. The balance of his Saving Bank Account(s) decreased for Rs.1,59,367/- this year. Thus a sum of Rs.6,58,701/- was therefore available with him to meet out the household expenditure of his family consisting of three members in the financial year 2012-13.

(2) In the financial year 2013-14, Sri Singh's annual income from salary and other Sources is Rs.8,99,685/- from this amount, he has paid Rs.2400/- against GIS, Rs.62,137/- against Income Tax, Rs.95,463/- against CPF, Rs.17,490/- (with interest), against PPF, Rs.56,170/- against LIC, Rs.21,200/- against NSC, Rs.1,80,000/- against Home loan installments. The balance of his Saving Bank Account(s) enhanced for Rs.32,733/- this year. As such, total deductions /Savings/investment is Rs.4,67,593/-. Thus a sum of Rs.4,32,092/- was therefore available with him to meet out the household expenditure of his family consisting of three members in the financial year 2013-14.

The movable and immovable property statement for the financial years 2012-13 and 2013-14 has been submitted by the officer vide his letter dated 11.9.14 (flag 'A') which was due to be submitted in the financial year 2014-15 i.e. on or before 31.3.15. As such there is no delay in submitting the Property statement for the aforesaid periods from the part of the officer.

In this connection, it is submitted that Sri Singh has already submitted his property statement upto financial year 2011-12 which was seen by Hon'ble Mr. Justice Sudhir Agarwal, the then Administrative Judge, Budaun on 22.7.13 at flag 'Z' and the said statement is at flag 'M'.

May, if approved, the statements of movable and immovable property for the financial years 2012-13 and 2013-14 of Sri Jitendra Singh, Judicial Magistrate, Budaun may kindly be laid before Hon'ble Mr. Justice Dinesh Maheshwari, Administrative Judge, Budaun Judgeship for His Lordship's kind perusal and orders?
