May kindly see the letter, placed below at flag 'A', received from Sri Jitendra Singh, Additional Civil Judge (Sr. Div.), Muzaffarnagar regarding submission of the statement of movable property exceeding to value of one month's basic pay and immovable properties acquired/held by him or any member of his family for the financial years 2014-15 and 2015-16 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable property for the financial years 2014-15 and 2015-16 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial year 2014-15, the total income is Rs.9,31,369/- (Rs.9,01,369/- from salary and Rs.30,000/- from agriculture) and from this amount, Rs.2,400/- is deducted against GIS, Rs.1,08,347/- against CPF, Rs.48,142/- against Income Tax, Rs.56,170/- against premium of LIC policies, Rs.19,012/- (including interest) deposited in his PPF account and Rs.1,80,000/- against Home loan. The balance of his savings bank account(s) enhanced for Rs.1,38,723/- this financial year. As such, total deductions/ repayment/ savings/ investment is Rs.5,52,794/-. Thus, a sum of Rs.3,78,575/- was therefore available with him to meet out the household expenditure of his family consisting of three members in whole of the financial year.

(2) In the financial year 2015-16, the total income is Rs.10,35,473/- (Rs.10,03,473/- from salary and Rs.32,000/- from agriculture) and from this amount, Rs.3,200/- is deducted against GIS, Rs.1,03,705/- against CPF, Rs.65,838/- against Income Tax, Rs.76,170/- against premium of LIC policies, Rs.20,666/- (including interest) deposited in his PPF account and Rs.1,80,000/- against Home loan. As such, total deductions/ repayment/ savings/ investment is Rs.4,49,579/-. The balance of his savings bank account(s) reduced for Rs.61,094/- this financial year. Thus, a sum of Rs.6,46,988/- was therefore available with him to meet out the household

expenditure of his family consisting of three members in whole of the financial year.

In this connection it is submitted that Sri Jitendra Singh has already submitted his property statement upto the financial year 2013-14 (statement is at flag 'M') which had already been seen by Hon'ble Mr. Justice Bharat Bhushan, the then Administrative Judge, Budaun on 12.05.2015 at flag 'Z'.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial year 2014-15 & 2015-16 in its next financial year i.e., 2016-17 up to March 2017. He has submitted the movable and immovable property statement for the financial year 2014-15 & 2015-16 vide his letter dated 11.04.2016 (at flag 'A'). As such, there is no delay in submitting the aforesaid property statements from the part of the officer.

May, therefore, if approved, the property statements for the financial years 2014-15 & 2015-16 alongwith letter dated 11.04.2016 (at flag 'A') of Sri Jitendra Singh, Additional Civil Judge (Sr. Div.), Muzaffarnagar be laid before Hon'ble Mr. Justice Ran Vijai Singh, Administrative Judge, Muzaffarnagar for His Lordship's kind perusal and orders?
