May kindly see the letter, placed below at **flag 'A'**, received from Sri Jitendra Singh-II, Civil Judge (Sr. Div.), Muzaffarnagar regarding submission of statement of movable property exceeding to value of one month's basic pay and immovable properties acquired/held by him or any member of his family for the financial years 2016-17 and 2017-18 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable property for the financial years 2016-17 and 2017-18 of the officer concerned, details of income, deductions, savings investment and expenditure made by him are given below.

(1) In the financial year 2016-17, income from salary is Rs.12,24,076/- and income from agriculture is Rs.4,40,000/-. Thus, the total income is Rs.16,64,076/- and from this amount, Rs.4,800/- is deducted against GIS, Rs.1,04,400/- against Income Tax, Rs.1,07,618/- against CPF, Rs.1,80,000/- against home loan, Rs.56,170/- against premium of LIC policies and Rs.1,00,000/- deposited in his PPF account. As such, total deductions/ repayment/ savings/ investment is Rs.5,52,988/-. The balance of his savings bank account(s) reduced for Rs.60,865/- this financial year from previous year's balance. Thus, a sum of Rs.11,71,953/- was therefore available with him to meet out the household expenditure of his family consisting of four members in whole of the financial year.

(2) In the financial year 2017-18, income from salary is Rs.11,97,691/- and income from agriculture is Rs.4,50,000/-. Thus, the total income is Rs.16,47,691/- and from this amount, Rs.4,800/- is deducted against GIS, Rs.1,04,400/- against Income Tax, Rs.1,38,837/- against CPF, Rs.1,80,000/- against home loan and Rs.56,170/- against premium of LIC policies. The balance of his savings bank account(s) enhanced for Rs.1,02,283/- this financial year from previous year's balance. As such, total deductions/ repayment/ savings/ investment is Rs.5,86,090/-. Thus, a sum of Rs.10,61,601/- was therefore available with him to meet out the household expenditure of his family consisting of four members in whole of the financial year.

In this connection it is submitted that Sri Jitendra Singh-II has already submitted his property statement upto the financial year 2015-16 (statement is at **flag 'M'**) which had already been seen by Hon'ble Mr. Justice Ran Vijai Singh, the then

Administrative Judge, Muzaffarnagar at flag 'Z'.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial year 2016-17 & 2017-18 in its next financial year i.e., in 2018-19 upto March 2019. He has submitted the movable and immovable property statement for the financial year 2016-17 & 2017-18 vide his letter dated 04.04.2018 (at flag 'A'). As such, there is no delay in submitting the aforesaid property statements from the part of the officer.

May, therefore, if approved, property statements for the financial years 2016-17 and 2017-18 alongwith letter dated 04.04.2018 (at flag 'A') of Sri Jitendra Singh-II, Civil Judge (Sr. Div.), Muzaffarnagar be laid before Hon'ble Mr. Justice P.K.S. Baghel, Administrative Judge, Muzaffarnagar Judgeship for His Lordship's kind perusal and orders?
