May kindly see the letters, placed below at flag 'A', received from Sri Anil Kumar Kharwar, Additional Civil Judge (Jr. Div.), Pratapgarh, by which he has requested the Court to grant him permission to accept a Maruti Alto car as gift from his mother-in-law.

In his letter, Sri Kharwar has stated that his mother-in-law Smt Vimla Devi, W/o Sri Bhaiyya Lal, Asst. Teacher is the sole owner of Maruti Alto car bearing registration no. UP-65-AF-4938. She is willing to gift and transfer the car to him out of natural love and affection. He has also submitted consent letter of his mother-in-law in this regard as well as a copy of registration certificate of the car, which are at flags 'B' & 'B-1'. He has, therefore, requested the Court to grant him permission to accept the car as a gift from his mother-in-law.

In this connection, it is submitted that the relevant rule relating to gift [Rule 11 of the U.P. Government Servant's Conduct (Amendment) Rules, 1998] and Rule-24 (2) of U.P. Government Servant's conduct (Amendment) Rules, 1998 relating to transfer of movable property are as follows: -

- 11. Gifts:- A government servant shall not without previous approval of Government :-
 - (a) Accept directly or indirectly on his own behalf or on behalf of any other persons, or
 - (b) Permit any member of his family who is dependent on him, to accept

Any gift, gratuity or reward from any person other than a close relative.

24(2)- "A Government servant who enters into any transaction concerning any movable property exceeding in value, the amount of his basic pay for one month, whether by way of purchase, sale or otherwise, shall forthwith report such transaction to the appropriate authority;

Provided that no Government servant shall inter into any such transaction except with or through a reputed dealer or agent of standing, or with the previous sanction of the appropriate authority."

It is further submitted that as the officer has requested for grant of permission to accept the car as gift from his mother-in-law, who appears to be a close relative of the officer, he may be granted the permission, as requested, as per the rules referred to above, if the Court deemed fit and proper.

May, therefore, if approved by Hon'ble Mr. Justice M. I. Murtaza, Sri Anil Kumar Kharwar, Additional Civil Judge (Jr. Div.), Pratapgarh be granted permission to accept the Maruti Alto car bearing registration no. UP-65-AF-4938 as gift from his mother-in-law Smt. Vimla Devi, as requested, with the direction that he may furnish copies of the relevant papers of transaction after its completion?

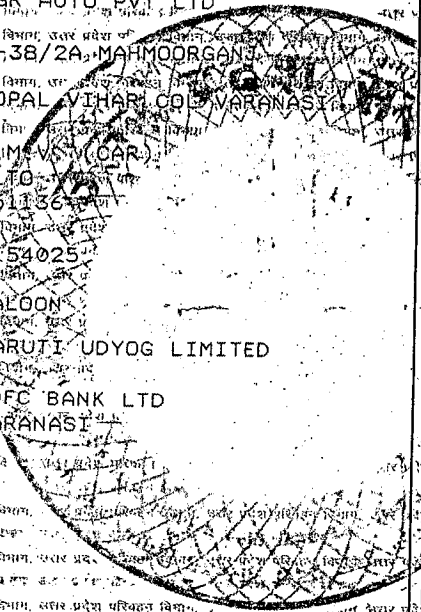
