May kindly see the letter, placed below at flag '1', received from Sri Anil Kumar Kharwar, Additional Civil Judge (Junior Division), Mirzapur, by which he has requested for grant of permission to purchase a firearm (Pistol).

In this connection it is submitted that earlier Sri Kharwar, vide his application dated 10.02.2011 (flag 'A') had submitted a copy of firearm's licence (flag 'B') and had applied for grant of permission to purchase a firearm. Accordingly, an office note dated 15.09.2011 (flag 'X') was submitted before Hon'ble Mr. Justice Imtiyaz Murtaza, with the remark that the officer has not submitted details of the firearm, which he wants to purchase as well as not submitted all the details of the proposed transaction, which generally required in detail in such type of application, upon which His Lordship, by indicating the said remark as 'A', has been pleased to pass order dated 26.09.2011 to **Seek details as at 'A' alongwith indicating the pressing need for possessing arms.**

The order of His Lordship has been communicated to the officer concerned vide Court's letters dated 13.10.2011 (flag 'C') & 22.11.2011 (flag 'D').

In reply of the Court's letter dated 13.10.2011 & 22.11.2011, Sri Kharwar, through his letters dated 19.10.2011 (flag '2') & 25.11.2011 (flag '1') has stated that he has to purchase a Pistol for his personal security. Pistol will be purchased from Koshipore, Kolkata. At present, only licence has been issued in his favour, and Pistol is yet to be purchased. For purchase of firearm, no transaction is proposed as yet.

Under the facts and circumstances, if approved, the file may be laid before Hon'ble Mr. Justice Sanjay Misra for His Lordship's kind perusal and orders in the matter of grant of permission to Sri Anil Kumar Kharwar, Additional Civil Judge (Junior Division), Mirzapur to purchase a firearm (Pistol) from Koshipore, Kolkata?
