May kindly see the letter, placed below at flag '1A', received from Sri Rajiv Maheshwaram, Deputy Director, Institute of Judicial Training & Research, U.P., Lucknow, in the matter of issuance of 'No-Objection Certificate' for obtaining Passport.

In this connection, it is submitted that on the request of Sri Rajiv Maheshwarar., Deputy Director, Institute of Judicial Training & Research, U.P., Lucknow, Hon'ble Mr. Justice Abdul Mateen, Administrative Judge, Lucknow has been pleased to pass order dated 25.05.2011 (flag '2A'), approving the proposal for issuing "No Objection Certificate' to the officer by the Registrar Budget subject to furnishing the following information by the officer, if not already furnished:-

1. In case he is granted permission for going abroad, will there be any possibility for creating anomalous position to the State/ Central Government.
2. Whether such type of request was ever refused to him?
3. Whether he has visited any foreign country till now, and if yes, to give details thereof ?
4. An undertaking that he will not engage, directly or indirectly, in any trade business or any employment in foreign country and he will join his duties after expiry of leave-period.
5. An undertaking to disclose the purpose and source of expenses to be incurred.
6. Any other information/ formality as would appear necessary.

As per order of the Court, the specific informations has been asked from the officer vide Court's letter dated 25.06.2011 (flag '3A').

Now, in reply of Court's letter dated 25.06.2011, Sri Maheshwaram through his letter dated 01.07.2011(flag '1A') has submitted the required informations, as follows:-

1. His conduct during his visit to a foreign country, shall not cause any embarrassment to the Government of India or the government of Uttar Pradesh.
2. This is the first time that he is applying for issue of 'No Objection Certificate' thereby no such request has been refused earlier.
3. He has not visited any foreign country, so far.
4. He give the undertaking that he will not engage, directly or indirectly, in any trade business or any employment in foreign country and will join his duties immediately after expiry of the leave period.
5. He also give the undertaking, that as and when he will make a request before the Hon'ble Court, about any intended foreign visit, he shall disclose the purpose and source of expenses to be incurred.

He has, therefore, requested to place the above information/ undertaking for issuance of 'No Objection Certificate' for obtaining passport.

It is further submitted that as the officer has furnished all the required informations, 'No Objection Certificate' may be issued to him now as per Court's order

dated 25.05.2011 (flag '2A').

A Under the facts and circumstances mentioned above, if approved, the file may be laid before Ld. Registrar (Budget) for approval and signature on the 'No Objection Certificate' at flag '2' in the matter?
