May kindly see the letter dated 3.10.13 (flagged 'A') by which Sri Rajiv Maheshwaram, Deputy Secretary, U. P. State Legal Services Authority, Jawahar Bhawan, Lucknow has submitted his Movable and immovable property statement for the financial years 2008-09, 2009-10, 2010-11, 2011-12.

In this connection, it is submitted that as per statement of movable and immovable property for the financial years 2008-09, 2009-10, 2010-11 and 2011-12 of the officer concerned, details of income, deductions, Savings, investment and expenditure made by him, are given below.

(1) In the financial year 2008-09, Sri Maheshwaram's total income from salary is Rs.2,52,345/- from this amount Rs.99,339/- are deducted against GIS, LIC and PPF. As such, total deductions/ repayment/ Savings /investment is Rs.99,339/-. Thus a sum of Rs.1,53,006/- was therefore available with him to meet out the household expenditure of his family consisting of four member in the financial year 2008-09.

(2) In the financial year 2009-10, Sri Maheshwaram's total income from salary is Rs.3,95,008/- from this amount Rs.1,00,000/- is deducted against GIS, LIC and PPF. and balance of his Saving Bank Account(s) enhanced for Rs.1,00,000/-(approx.) this year. As such, total deductions/repayment/Savings/investment is Rs.2,00,000/-. Thus a sum of Rs.1,95,008/- was therefore available with him to meet out the household expenditure of his family consisting of four member in the financial year 2009-10

(3) In the financial year 2010-11, Sri Maheshwaram's total income from salary is Rs.11,95,002/- from this amount Rs.2,18,790/- is deducted against GIS, LIC, PPF and Interest of Housing loan and, balance of his Saving Bank Account(s) enhanced for Rs.75,000/-(approx.) this year. As such, total deductions/ repayment/Savings/ investment is Rs.2,93,790/-. Thus a sum of Rs.9,01,212/- was therefore available with him to meet out the household expenditure of his family consisting of four member in the financial year 2010-11.

(4) In the financial year 2011-12, Sri Maheshwaram's total income from salary is Rs.11,04,136/- from this amount Rs.2,36,680/- is deducted against GIS, LIC, PPF and Interest of Housing loan. As such, total deductions/ repayment/Savings/ investment is Rs.2,36,680/-. Thus a sum of Rs.8,67,456/- was therefore available with him to meet out the household

expenditure of his family consisting of four member in the financial year 2010-11.

It is pertinent to mention here that wife of the officer Dr. Shradha Rai earns approx. Rs.50,000/- and 75,000/- per year from temporary teaching and writing assignments.

The movable and immovable property statement for the financial years 2008-09, 2009-10, 2010-11 and 2011-12 has been submitted by the officer vide his letter dated 3.10.13 (flagged 'A') which was due to be submitted in third financial years 2010-11 and 2012-13 i.e on or before 31.3.11 and 31.3.13 respectively. As such there is delay in submitting the aforesaid Property statement from the part of officer.

In this connection it is submitted last time Sri ^{Maheshwaram} Gupta had already submitted his property statement upto financial year 2007-08 which had already been seen by Hon'ble Mr. Justice Prakash Krishna, the then Administrative Judge, Allahabad Judgeship on 9.6.10, which is at flag 'Z' and the said statement at flag 'M'.

May, if approved, the statements of movable and immovable property for the financial years 2008-09, 2009-10, 2010-11 and 2011-12 of Sri Rajiv Maheshwaram, Deputy Secretary, U. P. State Legal Services Authority, Jawahar Bhawan, Lucknow may kindly be laid before Hon'ble Mr. Justice Arun Tandon, Administrative Judge, Lucknow Judgeship for His Lordship's kind perusal and orders ?
