May kindly see the letters, placed below at flag 'A', & 'A-I' received from Sri Rajiv Maheshwaram, Dy. Secretary, U. P. State Legal Service Authority, Lucknow regarding submission of statement of movable property exceeding to value of one month's basic pay and immovable properties acquired/held by him or any member of his family for the financial years 2012-13 and 2013-14 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that earlier Sri Rajiv Maheshwaram had submitted his movable & immovable property statements for the financial years 2012-13 and 2013-14 through his letter dated 16-07-2015 (flagged 'A'). Thereafter he was asked to furnish some information vide Court's letter dated 26-08-2015 (flagged 'C').

Now, Sri Rajiv Maheshwaram has submitted required informations alongwith required through his letter dated 21-12-2015 (flagged 'A-I').

In this connection, it is submitted that as per statement of movable and immovable property for the financial years 2012-13 and 2013-14 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial year 2012-13, the income from salary and other allowances is Rs.09,09,574/- and from this amount, Rs.4800/- is deducted against GIS, Rs.40,099/- against LIC, Rs.65,890/- against Income Tax, Rs.56,300/- against NSC, Rs.1,92,144/- against house loan and Rs.1,00,000/- (included interest) deposited in his PPF account in this years. The balance of his savings bank account (s) enhanced for Rs.33,085/- this year. As such, total deductions/ repayment is Rs.04,92,318/-. Thus, a sum of Rs.04,17,256/- was therefore available with him to meet out the household expenditure of his family consisting of five members in whole of the financial year 2012-13.

(2) In the financial year 2013-14, the income from salary and other allowances is Rs.11,24,571/- and from this amount, Rs.4800/- is deducted against GIS, Rs.40,099/- against LIC, Rs.96,582/- against Income Tax, Rs.87,800/- against NSC, Rs.1,94,714/- against house loan and

Rs.1,00,000/- (included interest) deposited in his PPF account in this years. As such, total deductions/ repayment is Rs.05,23,995/-. The balance of his savings bank account (s) reduced for Rs.1,42,034/- this year. Thus, a sum of Rs.07,42,610/- was therefore available with him to meet out the household expenditure of his family consisting of five members in whole of the financial year 2013-14.

In this connection it is submitted that Sri Rajiv Maheshwaram has already submitted his property statement of the financial year 2011-12 (statement is at flag 'M') which had already been seen on 25-11-2013 by Hon'ble Mr. Justice Arun Tandon, the then Administrative Judge, Lucknow Judgeship at flag 'Z'.

It is further submitted that as as per policy/Court's Circular Letter, the officer has to submit his property statement for the years 2012-13 & 2013-14 in its next financial year i. e. in 2014-15 up to March 2015. He has submitted the same through his letter dated 16-07-2015 and as such, there is delay in submitting the same statements for the years 2012-13 and 2013-14.

May, therefore, if approved, the property statements for the financial years 2012-13 and 2013-14 alongwith letters dated 16-07-2015 & 21-12-2015 (flagged 'A' & 'A-I' ) of Sri Rajiv Maheshwaram, Dy. Secretary, U. P. State Legal Service Authority, Lucknow be laid before Hon'ble Mr. Justice Vikram Nath, Administrative Judge, Lucknow Judgeship for his Lordship's kind perusal and orders?
