May kindly see the letter dated 16.9.13 (flagged 'A' ) by which Sri Rajat Verma, Additional Civil Judge(Sr.Div.), J.P.Nagar has submitted his PPF A/c balance mentioned in the Property statement for the financial years 2010-11.

Earlier Sri Verma has submitted his property statement for the financial years 2010-11 and 2011-12 vide his letter dated 6.7.13(flagged 'B') in which he has mentioned ~~his~~ <sup>Balance of his</sup> incorrect PPF A/c ~~balance~~ then a Court's letter dated 22.8.13(flagged 'C') was sent to the officer in this regard.

In reply of aforesaid Court's letter, Officer has submitted ~~his~~ <sup>balance of his</sup> correct PPF A/c ~~balance~~ mentioned in his property statement for the financial year 2010-11 vide his letter dated 16.9.13(flagged 'A').

In this connection it is submitted that from perusal of the Property statement for the financial year 2010-11, Sri Varma Gross income from salary is Rs.7,90,034/- from this amount he has subscribed/deposited Rs.56,531/- in New Pension Scheme, Rs.1440/- in GIS, Rs.1,40,000/- in PPF, Rs.35,054/- is LIC premium and Rs.3,82,815/- in Saving Bank Account. The total deduction and investment is Rs.6,15,840/-. Thus a sum of Rs.1,74,194/- was therefore available to him to meet out his family expenditure in whole year.

In financial year 2011-12, Sri Verma Gross income from salary is Rs.11,64,789/- from this amount he has subscribed/deposited Rs.38,416/- in New Pension Scheme, Rs.3680/- in GIS, Rs.75,000/- in Saving Bank Account, Rs.10,000/- in PPF and Rs.35,054/- in LIC. The total deduction and investment is Rs.1,62,150/-. Thus a sum of Rs.10,02,639/- was therefore available to him to meet out his family expenditure in whole year.

The movable and immovable property statement for the financial years 2010-11 and 2011-12 has been submitted by the officer vide his letters dated 6.7.13 (flagged 'A') which was due to be submitted in third financial years 2012-13 i.e on or before 31.3.13 . As such there is some delay in submitting the property statement for the financial year 2010-11 and 2011-12 from the part of officer.

In this connection it is submitted that Officer has already submitted his <sup>Property</sup> ~~Property~~ statement upto financial year 2009-10 has already been seen by Hon'ble Mr. Justice Rajiv Sharma, the then Administrative
