May kindly see the letter dated 26.10.13 (flagged 'A') by which Sri Rajat Verma, Additional Civil Judge(Sr.Div.), J.P.Nagar has submitted his PPF A/c balance mentioned in the Property statement for the financial years 2010-11.

Earlie Sri Verma has submitted his property statement for the financial years 2010-11 and 2011-12 vide his letter dated 6.7.13(flagged 'B') in which he has mentioned his incorrect PPF A/c ^{balance} ~~deposit for the years is not shown~~ balance then a Court's letter dated 22.8.13(flagged 'C') was sent to the officer in this regard. The officer has submitted his revised property statement for the aforesaid period vide his letter dated 16.9.13(flagged 'D'). But in the aforesaid statement his PPF A/c deposit for the year is not shown. Again a Court's letter dated 7.10.13 (flagged 'E') was sent to the officer.

In reply of aforesaid Court's letter, Officer has submitted his correct PPF A/c deposits mentioned in his property statement for the financial year 2010-11 vide his letter dated 26.10.13 (flagged 'A').

In this connection, it is submitted that as per details submitted and property statement of movable and immovable property for the financial years 2010-11 and 2011-12 of the officer concerned, details of income, deductions, Savings, investment and expenditure made by him are given below.

(1) In the financial year 2010-11, Sri Verma total income from salary is Rs.7,90,034/- from this amount RS.1440/- against GIS, Rs.56,531/- in new pension Scheme, 70,000/- against PPF, Rs.35,054/- is LIC premium. The balance of his Saving Bank Accounts(s) enhanced for Rs.382,815/- (approx.) this year. As such, total deductions/Savings/investment is Rs.5,45,840/-. Thus a sum of Rs.2,44,194/- was therefore available to him to meet out his family consisting of five members in the financial year 2010-11.

(2) In financial year 2011-12, Sri Verma total income from salary is Rs.11,64,789/- from this amount Rs.3680/- against GIS, Rs.94,947/- ~~56,531/-~~ in new pension Scheme, 1,00,000/- against PPF, Rs.35,054/- is LIC premium. The balance of his Saving Bank Accounts(s) enhanced for Rs.82,288/- (approx.) this year. As such, total deductions/Savings/investment is Rs.3,15,969/-. Thus a sum of Rs.8,48,820/- was therefore available to him to meet out his family consisting of five members in the financial year 2011-12

The movable and immovable property statement for the financial years 2010-11 and 2011-12 has been submitted by the officer vide his letter dated 6.7.13 (flagged 'B') which was due to be submitted in third financial years 2012-13 i.e on or before 31.3.13 . As such there is some delay in submitting the property statement for the financial year 2010-11 and 2011-12 from the part of officer.
