May kindly see the letter dated 4.9.2015 (at flag 'A') of Sri Rajat Verma, Additional Civil Judge(Sr.Div.)/Additional Chief Judicial Magistrate, J.P.Nagar by which he has submitted his clarification on certain points of income and expenditure for the financial year 2012-13 relating to the submission of Property Statements.

Earlier Sri Verma has submitted his property statements for the financial years 2012-13 alongwith property statements for the financial years 2010-11 and 2011-12. The property statements for the financial year 2012-13 was to be considered alongwith property statements for the financial year 2013-14, which has been submitted by the officer on 17.7.15(flag 'B') alongwith property statement for the financial year 2014-15, but on calculation of the property statements for the financial year 2012-13, income/savings/expenditure appeared not in proportion, hence a Court letter dated 20.8.2015 (flag 'C') has been sent to the officer to clarify the actual position and about managing of his family from rest of the amount as household expenses.

In reply of aforesaid Court's letter, officer has stated through his letter dated 4.9.2015 (flag 'A') that he had shown a FDR in his property statement for the financial year 2012-13 which is matured and credited in his S.B. A/c No...3488 on 23.3.13 so the balance of Saving Bank A/c has been enhanced for Rs.5,43,216/- and Rs.41,827/- also credited in the same account on 5.11.12 of Encasement of earned leave. He has further stated that he wrongly mentioned his gross Salary as Rs.11,64,748 instead of Rs.10,86,595/- and also wrongly mentioned the amount of New pension Scheme as Rs.3,35,654/- instead of Rs.1,52,794/- due to typographical mistake and regretted for the same and requested to accept the corrected details.

In this connection, it is submitted that as per statements of movable and immovable property for the financial years 2012-13 and 2013-14 of the officer concerned, details of income, deductions, Savings, investment and expenditure made by him are given below:-

(1) In the statement of movable and immovable property for the financial year 2012-13, Sri Verma's gross Income from Salary and other Sources is Rs.10,86,595/- from this amount, he has paid Rs.4800/- against GIS, Rs.1,52,794/- against NPS, Rs.2,00,000/- against PPF, Rs.10,117/- against LIC. The balance of his Saving Bank Account(s) enhanced for Rs.5,46,600/- this financial year. As such, total deductions / Savings/investment is Rs.9,14,311/-. He has also received an amount of Rs.5,43,216/- as maturity of FDR and Rs.41,827/- as encasement of earned leave this year. Thus, a sum of Rs.7,57,327/- was therefore available with him to meet out the household expenditure of his family consisting of four member in financial year 2012-13.

(2) In the statement of movable and immovable property for the financial year 2013-14, Sri Verma's gross Income from Salary and other Sources is Rs.11,32,423/- from this amount, he has paid Rs.4800/- against GIS, Rs.1,22,897/- against NPS, Rs.1,45,000/- against PPF, Rs.10,117/- against LIC. As such, total deductions /Savings/investment is Rs.2,72,697/-. The balance of his Saving Bank Account(s) decreased for Rs.5,28,539/- this financial year. Thus a sum of Rs.13,88,265/- was therefore available with him to meet out the household expenditure of his family consisting of four member in financial year 2013-14.

It is pertinent to mention here that the wife of the officer Mrs. Manisha Verma is a Lawyer engaged in practice whose annual Income is Rs.40,000/- (in the financial year 2012-13) and Rs.45,000/- (in the financial year 2013-14).

The movable and immovable property statement for the financial years 2012-13 has been submitted by the officer vide his letter dated 16.9.2013(flag 'B') and for the financial years 2013-14 has been submitted by the officer vide his letter dated 17.7.15(flag 'C') . The Property Statements for the financial years 2012-13 and 2013-14 was due to be submitted in the financial year 2014-15 i.e. on or before 31.3.15. As such there is delay in submitting the property statement for the financial year 2013-14 from the part of the officer for which officer has regretted.

I am further to say that the property statement for the financial year 2014-15 alongwith property statement for the financial year 2015-16 will be due in the financial year 2016-17 as per Court's Circular letter dated 13.5.04.

In this connection, it is submitted that Sri Verma has already submitted his property statement upto the financial years 2011-12 which was seen by Hon'ble Mr. Justice Kalimullah Khan, the then Administrative Judge, J.P.Nagar on 25.3.14 at flag 'Z' and the said statement is at flag-'M'.

May, if approved, the statements of movable and immovable property for the financial years 2012-13 and 2013-14 of Sri Rajat Verma, Additional Civil Judge(Sr.Div.)/Additional Chief Judicial Magistrate, J.P.Nagar may kindly be laid before Hon'ble Mr. Justice Bharat Bhushan, Administrative Judge, J.P.Nagar Judgeship for His Lordship's kind perusal and orders ?
