May kindly see the letter/ application at flag 'A', received from Sri Rajat Verma, Addl. Civil Judge (Senior Division), Etah for grant of permission to sell his immovable property i.e. 142 sq. meters of land, situated at Chandausi Distt. Bhimnagar.

In his application, Sri Verma has stated that prior to join the judicial service, he had purchased 142 sq. meters of land, situated at Chandausi Distt. Bhimnagar on 05.02.2005 in his name alongwith the name of his wife Smt. Manisha Verma, information of which was also submitted by him earlier. Now, he want to sell the same land to one Smt. Savitri Devi, W/o Sri Laxmi Narain, Mohalla Vikas Nagar, Chandausi, Distt. Bhimnagar for Rs. 3,75,000/-. Smt. Savitri Devi is not related to him in any way and no case of her is ever pending in his court. He has, therefore, requested for grant of permission to sell the land to Smt. Savitri Devi aforesaid.

In this connection, it is submitted that as per the records, it is seen that the land in question was acquired by the officer prior to joining the judicial service and he has mentioned the same in his property statements. It is further submitted that as per Rule- 24 (1) of U.P. Government Servant's conduct Rule-1956: -

"No Government servant shall, except with the previous knowledge of the appropriate authority acquire or dispose of any immovable property by lease, mortgage, purchase, sale, gift or otherwise, either in his own name or in the name of any member of his family;

Provided that any such transaction conducted otherwise than through a regular & reputed dealer shall require the previous sanction of the appropriate authority."

May, therefore, if approved, the file be laid before Hon'ble Mr. Justice Sanjay Misra for His Lordship's kind perusal and if His Lordship's approves, permission be accorded to Sri Rajat Verma, Addl. Civil Judge (Senior Division), Etah to sell his 142 sq. meters of land, situated at Chandausi Distt. Bhimnagar to Smt. Savitri Devi, W/o Sri Laxmi Narain, Mohalla Vikas Nagar, Chandausi, Distt. Bhimnagar for Rs. 3,75,000/-, as requested, subject to the conditions that he should submit the relevant papers of the transaction after its completion?
