मेडिकल बोर्ड की रिपोर्ट

उत्तर प्रदेश में इण्डियन सिविल को छोड़कर भारतीय प्रान्तीय नौकरियों में नियुक्ति के लिए उम्मीदवार के स्वास्थ्य परीक्षा सम्बन्धी नियमविधान, रेग्युलेशन)

1. उत्तर प्रदेश सरकार अन्तर्गत किसी नियुक्ति के लिए किसी उम्मीदवार को योग्य घोषित करने के निमित्त यह आवश्यक है कि उसका मानसिक और शारीरिक स्वास्थ्य अच्छा हो और वह किसी ऐसे शारीरिक दोष से रहित हो, जिसके कारण उसे अपने पद के कर्तव्यों को सुचारु रूप से पालन करने में बाधा पड़ने की संभावना हो।

2. यूरोपीय जाति के उम्मीदवारों की स्वास्थ्य परीक्षा करने के लिए आयु कद और छाती की चौड़ाई का पारस्परिक सम्बन्ध प्रदर्शित करने में, निम्नलिखित तालिका उदाहरण स्वरूप उपयोग में लानी चाहिए। यह भारतीय मिश्रित जातियों के सम्बन्ध में उपयोग में नहीं लायी जायेगी।

3. उम्मीदवार की लम्बाई इस प्रकार नापी जायेगी। वह अपने जूते उतारेगा और मापदण्ड (Standard) के सामने अपने दोनों पैर मिलाकर तथा एड़ियों के बल खड़ा होगा, न कि अंगूठों या पैर में बाहर की ओर देकर खड़ा होगा। वह स्वाभाविक रूप से सीधा खड़ा होगा और एड़ियां, पिंडलियां, चूतड़ और कंधे मापदण्ड को स्पर्श करें ठडडी को इस प्रकार नीचे किया जायेगा कि सिर के धरातल का सबसे ऊँचा भाग मापदण्ड के हारिजंटल-बार के नीचे लगा रहे और नं० को माप इन्चों में और इन्च के चौथाई भाग में लिखी जायेगी। इण्डियन पुलिस फोर्स के लिए कम से कम 5 फुट 4 इन्च की लम्बाई आवश्यक है, लेकिन अन्य विभागों में लम्बाई की कोई निर्धारित सीमा नहीं रखी गई है।

4. उम्मीदवार की छाती इस प्रकार नापी जायेगी। वह पाँव को मिलाकर अपने सिर के ऊपर दोनों बाहों को उठाकर सीधा खड़ा किया जायेगा फीता उसकी छाती के चारों ओर इस प्रकार रखा जायेगा कि उसका ऊपरी सिरा कन्धे की हड्डी के पीछे की ओर के निम्न कोणों को और उसका नीचे का सिरा सामने स्तनों की ढपेनी (Nipples) के ऊपरी भागों को छूता रहे। तब बाँहें नीचे की जायेंगी ताकि वे ढीले रूप में बगल की ओर लटकी रहें और इस बात का ध्यान रखा जायेगा कि कन्धे ऊपर या नीचे की ओर न किये जाये, जिससे फीता अपनी जगह से इधर उधर न हो। इसके बाद उम्मीदवार को कई बार गहरी साँस लेने के लिए आदेश किया जायेगा और सीने का अधिक से अधिक विस्तार सावधानी से लिख जायेगा, कम से कम और अधिक से माप इन्चों में लिखी जायेगी। 33-35 34-36-1/2 नापों को लिखने में 1/2 इन्च से कम भाग छोड़ देना चाहिए।

5. उम्मीदवार की तौल भी ली जायेगी और वजन पाउन्डों में लिखा जायेगा। एक पाउन्ड से कम भाग नहीं लिखा जायेगा।

6. **नोट :-** रेलवे कर्मचारियों और रायल इन्डियन मेरीन के चालाके (Pilot) के लिए विशेष नियम लागू हैं।

(क) दृष्टि की तीव्रता को जानने के लिए परीक्षा में 2 प्रकार की जाँच सम्मिलित हैं - एक दूर दृष्टि के लिए और दूसरी निकट दृष्टि के लिए दूर दृष्टि के लिए स्नेलन जाँच-विधियाँ प्रयोग में लायी जायेंगी, जो बिना ऐनक पहने हुए 20 फिट की दूरी से होगी, जो उम्मीदवार द्वारा चुनी जाय।

दृष्टि की न्यूनतम सूक्ष्मता के मापदण्ड - जो किसी उम्मीदवार की परीक्षा के लिए पथ प्रदर्शन के निमित्त प्रयोग में लाये जायेंगे निम्नलिखित हैं :-

भारतीय और प्रान्तीय पुलिस सर्विसों को छोड़कर अन्य सर्विसों के लिए मापदण्ड (Standard) अस्थाई रूप से घटाकर 6/60 कर दिया गया है।

- (क) प्रत्येक आँख के लिए यह आवश्यक है कि हाथ को हिला डुला के जाँच करने में दृष्टि-क्षेत्र में पूरा-पूरा हो।
- (ख) टेढ़ी दृष्टि या आँखों के या किसी आँख के पलकों की इस प्रकार व्याधि-ग्रस्त होने से जिससे आँख की बीमारी बढ़ जाने या फिर से पैदा होने की संभावना हो उम्मीदवार नहीं लिया जायेगा।
- (ग) हर आँख की जाँच अलग-अलग की जायेगी और जाँच के समय पलकें बिल्कुल खुली रहनी चाहिए।
- (घ) प्रमुख रोगी की पहचान की असमर्थता, अस्वीकृत होने के कारण नहीं होगी, लेकिन यह बात कार्यवाहियों में लिख दी जायगी और उम्मीदवार को उसकी सूचना दे दी जायेगी।
- (च) नौकरी के सब उम्मीदवारों की दृष्टि सूक्ष्मता की माप निम्नलिखित विधि से कार्यवाहियों के रजिस्टर में लिखी जायेगी -

7. पेशाब (परीक्षक के सामने की गई) की जाँच की जानी चाहिए और परिणाम लिख लिया जाना चाहिए।
8. इसके अतिरिक्त निम्नलिखित बातों का ध्यान देना चाहिए।
- (क) कि उम्मीदवार के प्रत्येक कान की श्रवण शक्ति अच्छी है और कोई कान की बीमारी का चिन्ह नहीं है।
- (ख) उसकी बोलचाल में कोई रुकावट नहीं है।
- (ग) उसके दाँत अच्छी हालत में हैं जहाँ की आवश्यक हो अच्छी तरह चबाने के लिए उतने दण्ड-पंक्ति लगा की। (समुचित रूप से भरे हुए दाँत अच्छे समझे जायेंगे।)
- (घ) उसकी छाती का गठन अच्छा है और उसकी छाती का फैलाव पर्याप्त है तथा उसके दिल और फुसफुस अच्छी अवस्था में है।
- (ङ) उसमें पेट की बीमारी के कोई लक्षण नहीं है।
- (च) उसका शरीर विदौर्ण नहीं है।
- (छ) उसे अण्ड वृद्धि, अत्यधिक मात्रा में अण्ड-कोष की नसों की सूजन और नसों का फूल आना या बवासीर नहीं है।
- (ज) उसके अंग हाथ और पैर अच्छे ढंग से देखे हैं और सुगठित है तथा उसके सम्पूर्ण जोड़ों की क्रियायें स्वच्छद और पूर्ण रूप से होती है।
- (झ) उसे किसी प्रकार का पुराना चर्म रोग नहीं है।
- (ट) उसके शरीर में कोई पैदाइशी अंग-विकृति या दोष नहीं है।
- (ठ) उसमें कोई नई या पुरानी बीमारी के चिन्ह, जो उसकी शारीरिक निर्बलता के सूचक हों नहीं है।
- (ड) उसके सफल टीके के चिन्ह विद्यमान हैं।

जब कोई दोष पाया जाय प्रमाण-पत्र पर उसका उल्लेख अवश्य कर देना चाहिए और स्वास्थ्य परीक्षक को अपनी अनुमति देना चाहिए कि इसके कारण उस कार्य को सुचारु रूप से सम्पादन करने में, जो उम्मीदवार को करना पड़ेगा, कोई बाधा पड़ने की सम्भावना है कि नहीं। यदि उसकी अवस्था आपरेशन करने से सुधर सकती हो, तो उसका उल्लेख कर देना चाहिए।
