Most humbly it is submitted that I sent a letter dated 05.12.2012 to the Hon'ble High Court, in which it was mentioned the address mentioned in the passport which I had was no more my address. Therefore for the change of particulars regarding my current address in my passport, 'No Objection Certificate' might be issued by the Hon'ble High Court.

The Hon'ble High Court in its letter no.:1661/TV-3508/Admin(A)/Dated 02.02.2013 was pleased to mention that 'No Objection Certificate' was issued to a Government Servant only for obtaining to passport. However, for any correction in the existing passport there was no provision for issue of 'No Objection Certificate'. With the aforesaid letter, I applied to the Passport Office, Ministry of External Affairs, Government of India for the required correction.
