May kindly see the letters, placed below at flag 'A', 'A-1' & 'A-2', received from Sri Anupam Goyal, Additional Director (Research), Judicial Training & Research Institute, U.P., Lucknow regarding issuance of 'No Objection Certificate' for obtaining fresh Passport due to change in address.

In his letter (flagged 'A'), Sri Goyal has stated that he is posted as Additional Director (Research) at the Institute of Judicial Training & Research, Lucknow, U.P. The address (9/27, Kaesar Ganj Road, Delhi Gate, Meerut) given in his passport was his previous address. Now his permanent address is **'White House, G-47-48, Vrindavan Enclave, Shatabdi Nagar-1, Delhi Road, Meerut'** (copy of passport is at flag 'B'). Therefore, he needs that previous address given in his passport may be replaced with the present address. For the aforesaid change of the address, he needs a 'No Objection Certificate' to be issued by the Hon'ble High Court.

On receipt of his said letter, the officer has been informed vide Court's letter dtd. 02.02.2013 (flag 'C') that as per relevant provisions/Government order, 'No Objection Certificate' is issued to a Government Servant only for obtaining passport and not for any correction in existing passport and as he is already having a passport, there appears to be no provision for issuance of 'No Objection Certificate' for any such correction in change of address etc.

The officer has sent reply of the Court's letter dtd. 02.02.2013, through his letters (flagged 'A-1' & 'A-2'), in which he has stated that he had applied to the Passport office, Ministry of External Affairs, Government of India for the required correction i.e. change of address with the Court's letter dtd 02.02.2013. However, the Regional Passport Officer, Lucknow in its letter no. LKo77807332014 dated 06.06.2014 (flagged 'D') had mentioned that for correction of any particulars in the existing passport, one has to apply afresh. Those cases might be treated as reissue case, case for which the government officer had to produce 'No Objection Certificate'. It was also mentioned for him to provide 'No Objection Certificate' from the Registrar, Hon'ble High Court. Thus, in the light of aforesaid letter of the Regional Passport Officer, Lucknow, Passport Office, Ministry of External Affairs, Government of India, he has requested to issue 'No Objection Certificate' for obtaining fresh passport. He has enclosed four passport size photographs of himself and required 'Affidavit' (flag 'E') in connection with declarations as per G.O. and Section 6 (2) of Passport Rules. His dependent is Smt. Kusum Lata Goyal (Mother). He has, therefore, requested for issuance of 'No Objection Certificate' for obtaining fresh passport due to change in address.

In this connection, it is submitted that issuance of 'No Objection Certificate' i.e. 'Identity Certificate' on new proforma for obtaining Passport is considered in accordance to the G.O.1/3/98-Ka-Prasko/1999 dated 14 June 1999 (flagged 'F'). He has requested for the same from the Court. As per reports, placed below, no vigilance/ departmental enquiry is pending against Sri Goyal. His request is considerable, as he has submitted required details and papers in this connection.

Under the facts and circumstances, mentioned above, if approved by Hon'ble Mr. Justice Arun Tandon, Administrative Judge, Lucknow Judgeship, 'Identity Certificate' at flag 'G' be issued, in duplicate, in favour of Sri Anupam Goyal, Additional Director (Research), Judicial Training & Research Institute, U.P., Lucknow as requested, for obtaining fresh Passport with the direction that he should take prior permission of the Court before proceeding abroad?
