May kindly see the letter of Dr. Anupam Goyal, Additional District & Sessions Judge, BulandShahr duly forwarded by the District Judge, Bulandshahr placed below at Flag ' A '.

In his aforesaid letter Dr. Goyal has stated that he was appointed Additional District & Sessions Judge in year 2008. He has also stated that before that besides being an advocate, he was also delivering lectures at evening centre of Faculty of Law, University of Delhi and completed his degree of Ph.D. in Law in year 2002. He has also stated that South Asian University, at New Delhi has recently invited the application for the post of Professor, Associate Professor and Assistant Professor, in faculty of Legal Studies and he was eligible candidates for all the three posts and if selected at the interview, he will be willing to join there for a period of 1 to 2 years. In this regard South Asian University requires "No Objection Certificate".
