

WHEREFORE, in exercise of powers conferred under Article 235 of the Constitution of India and all other powers enabling in this behalf, the Hon'ble Court has been pleased to place you under suspension from the date and time of your joining at district Lalitpur on usual subsistence allowance.

During suspension period you shall be paid subsistence allowance under the provision of Fundamental Rule – 53 part II to IV of Financial Hand Book Volume-II at an amount equal to the leave salary which you would have drawn if you had been on leave on half average pay or on half pay and in addition, dearness allowance if admissible on the basis of such leave salary. But no dearness allowance shall be paid along with subsistence allowance if dearness allowance was not payable to you with the salary before suspension or if marginal adjustment in respect of dearness allowance was not available.
