May kindly see the following resolution passed by the Hon'ble Administrative Committee in its meeting held on 19.7.2016 on consideration of the explanation dated 26.11.2015 submitted by Sri Anupam Goyal, Additional District & Sessions Judge, Kushinagar at Padrauna in reply to Show Cause Notice dated 17.10.2015, issued by the Hon'ble Court to explain as to why his absence from duty be not treated as abandonment of service:-

"Resolved that the Administrative Committee does not find the explanation dated 26.11.2015 of the aforesaid officer to be satisfactory. Hence the services of Sri Anupam Goyal, aforesaid be treated as abandoned with effect from the date of resolution and the officer be informed accordingly..."

In compliance of the aforesaid resolution, the officer was informed accordingly vide D.O. Letter No. C-1557/Cf.(A)/2016 dated 28.7.2016. Also, a copy of the said resolution was provided to Registrar(J)(Services) and Registrar(J)(Budget) for information and further necessary action at their end.

Thereafter, the representation dated 26.09.2016 of Sri Anupam Goyal requesting for withdrawal of the said D.O. Letter No. C-1557/Cf.(A)/2016 dated 28.7.2016, whereby his services have been treated as abandoned, was considered and rejected by the Hon'ble Administrative Committee in its meeting held on 9.11.2016.

If approved, the Registrar(J)(Budget) and Joint Registrar(J)(Services) may be requested to direct the officer concerned to provide a report regarding action taken, if any, in compliance of Hon'ble Administrative Committee resolution dated 19.7.2016 in the matter of abandonment of services of Sri Anupam Goyal, Additional District & Sessions Judge, Kushinagar at Padrauna?

The District Judge has reported that vide notification dated 15 September 2014 the officer took over charge of Additional District & Sessions Judge, Court No. 1, Kushinagar on 19 September 2014 and he left the judgeship on the same day to participate in some training programmes. Thereafter the officer has not joined at the place of his posting, nor has taken any leave. By his letter dated 27

February 2015 the officer has stated that whenever he returns to the Judgeship, he will submit an application for leave without pay and that he is constrained to be on leave for a long period.

Resolved that a show cause notice be issued to the officer to explain as to why his absence from duty be not treated as abandonment of service, since leave is not a matter of right and there is a persistent refusal to join at the place of posting.
