Respected Sir,

Most humbly it is submitted that the date of my joining into service in Higher Judicial Services cadre was 15.12.2008. On that date I was appointed as Additional District and Sessions Judge in district Mainpuri. In latter half of the year 2009 Hon'ble High Court was pleased to create my court as extra special court for Dacoity Affected Areas. During the same time in the year 2009, I applied for grant of the license of arms before the district administration, Meerut as my permanent address is of district Meerut. The district administration, Meerut granted me the license for keeping the arms in December, 2011. An amount of payment on Rs. 25,000/- vide draft no. 112973 dated 29.08.2012 drawn on State Bank of India, Partapur, Meerut was sent to the General Manager, Ordinance Factory, Muradnagar towards an advance payment for purchasing the arms. However, delivery of the arm was made to me on date 30.12.2013 for which the payment was made through two drafts respectively for amounts of Rs. 19,639/- vide draft no.015634 dated 30.12.2013 and for an amount of Rs. 49,000/- vide draft no.015635 dated 30.12.2013 and the delivery was made.

In this regard it is notable that the Hon'ble High Court in the meantime was pleased to issue Circular Letter No. 11/Ivh-16/Admin. (A): Dated 12.04.2010. In the said circular letter it was mentioned that the application to obtain necessary permission for purchase of firearms was to be made in the court at the time of submission of application for grant of such license. However, in the case of undersigned, application for the grant of license submitted well before the issue of the aforesaid circular letter i.e. in the year 2009. In other words, the submission of application for grant of license by the undersigned predates to the aforesaid circular letter. As per the position prevailing in the year 2009 the time when undersigned submitted the application for the grant of license, the undersigned

had to intimate the Hon'ble High Court when the movable property (arm) were purchased.

As I have purchased the arm in December, 2013, I am sending herewith the necessary details in view of the circular letter no. 25/ Admin. (A) dated 13th July, 1998 -

- (1) Date of joining the service: 15.12.2008.
- (2) Present Gross Salary and take home Salary: Rs.1,31,500/- and Rs. 1,13,650 respectively.
- (3) The details of purchase:
 - (i) Rs. 25,000/- on date 29.08.2012;
 - (ii) Rs. 49,000/- on date 30.12.2013; and
 - (iii) Rs. 19,639/- on date 30.12.2013.
- (4) No advance or loan taken either from Hon'ble High Court or the Bank.
- (5) Address of the dealer/seller: 'General Manager, Ordinance Factory, Muradnagar'.

At present I am appointed as Additional Director (Research) in the Judicial Training and Research Institute, U.P., Lucknow. During last six months, number of training programmes for newly recruited Additional District & Sessions Judges/newly recruited Civil Judges (Junior Division) and refresher courses were going on continuously. Therefore, there might be the delay of about three months in sending the intimation. Kindly, condone the aforesaid delay.
