May kindly see the letter, placed below at flag 'A' & 'B', received from Sri Tej Pratap Tiwari, Secretary, U.P. State Legal Services Authority, Lucknow regarding submission of statement of movable property exceeding to value of one month's basic pay and immovable properties acquired/held by him or any member of his family for the financial years 2012-13 and 2013-14 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that earlier Sri Tej Pratap Tiwari, Secretary, U.P. State Legal Services Authority, Lucknow has submitted the property statement of movable and immovable property for the financial years 2012-13 and 2013-14 through his letter dated 30.07.2015 (at flag 'A') but some information have not been found in the aforesaid statements. Accordingly, a Court's letter dated 02.09.2015 (at flag 'C') has sent to the Member Secretary, U.P. State Legal Services Authority, Lucknow with the request to kindly ask Sri Tej Pratap Tiwari, Secretary, U.P. State Legal Services Authority, Lucknow to furnish the incomplete details/information to the Court, so that further necessary action may be taken in the matter.

The officer has fulfilled required details through his letter dated 30.09.2015 (at flag 'B').

In this connection, it is submitted that as per statement of movable and immovable property for the financial years 2012-13 and 2013-14 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

- (1) In the financial year 2012-13, the income from salary is Rs.12,23,537/- and from this amount, Rs.4,800/- is deducted against GIS, Rs.1,28,121/- against Income Tax, Rs.11,590/- against Premium of LIC policies, Rs.500/- against motor vehicle allowance, Rs.1,42,104/- against Housing Loan. Rs.1.20.000/- against RD. Rs.4.00.000/- investment against

purchase of land and Rs.6,000/- deposited in his PPF account. As such, total deductions/ repayment/ savings/ investment is Rs.8,13,115/-. The balance of his savings bank account(s) reduced for Rs.14,44,635/- this financial year. Thus, a sum of Rs.18,55,057/- was therefore available with him to meet out the household expenditure of his family consisting of three members in whole of the financial year.

(2) In the financial year 2013-14, the income from salary is Rs.15,69,863/- and from this amount, Rs.4,800/- is deducted against GIS, Rs.1,64,969/- against Income Tax, Rs.61,590/- against Premium of LIC policies, Rs.1,42,104 against Housing Loan, Rs.1,20,000 against RD, Rs.74,074 against Car Loan and Rs.71,000/- deposited in his PPF account. The balance of his savings bank account(s) enhanced for Rs.70,393/- this financial year. As such, total deductions/ repayment/ savings/ investment is Rs.6,43,930/-. Thus, a sum of Rs.9,25,933/- was therefore available with him to meet out the household expenditure of his family consisting of three members in whole of the financial year.

In this connection it is submitted that Sri Tej Pratap Tiwari has already submitted his property statement upto the financial year 2011-12 (statement is at **flag 'M'**) which had already been seen by Hon'ble Mr. Justice Vineet Saran, the then Administrative Judge, Lucknow on 18.02.2013 at **flag 'Z'**.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial year 2012-13 & 2013-14 in its next financial year i.e., 2014-15 upto March 2015. He has submitted the movable and immovable property statement for the financial year 2012-13 and 2013-14 firstly vide his letter dated 30.07.2015 (at **flag 'A'**). As such, there is delay in submitting the property statements for the financial year 2012-13 & 2013-14 from the part of the officer.

May, therefore, if approved, the property statements for the financial years 2012-13 and 2013-14 alongwith letters dated 30.07.2015 (at **flag 'A'**) and 30.09.2015 (at **flag 'B'**) of Sri Tej Pratap Tiwari, Secretary, U.P. State Legal services
