May kindly see the letter/ application at flag 'A', received from Sri Tej Pratap Tiwari, Principal Judge, Family Court, Varanasi for grant of permission to sell his immovable property i.e. House no: T-4, Pushp Vihar Apartment, Hastings Road, Allahabad.

In his application, Sri Tiwari has stated that house no. T-4, Pushp Vihar Apartment, Hastings Road, Allahabad is owned by him in his name alongwith the name of his wife. Sale transaction of the said house is fixed with one Sri Surendra Nath Singh, S/o Sri Ramjanam Singh, R/o 98/ 217, Himmatganj, Allahabad for Rs. 19,00,000/-. He is not related to the purchaser in any way. From the amount of sale transaction and after taking loan, he is willing to purchase a house in Lucknow. He has also submitted a copy of 'Agreement' prepared in this regard (flag 'B') and has, therefore, requested for grant of permission to sell the house.

In this connection, it is submitted that as per the records, it is seen that the house in question was acquired by the officer prior to joining the U.P.H.J.S.. It is further submitted that as per Rule- 24 (1) of U.P. Government Servant's conduct Rule-1956: -

"No Government servant shall, except with the previous knowledge of the appropriate authority acquire or dispose of any immovable property by lease, mortgage, purchase, sale, gift or otherwise, either in his own name or in the name of any member of his family;

Provided that any such transaction conducted otherwise than through a regular & reputed dealer shall require the previous sanction of the appropriate authority."

May, therefore, if approved, the file be laid before Hon'ble Mr. Justice Sanjay Misra for His Lordship's kind perusal and order that permission be accorded to Sri Tej Pratap Tiwari, Principal Judge, Family Court, Varanasi to sell house no. T-4, Pushp Vihar Apartment, Hastings Road, Allahabad to Sri Surendra Nath Singh, S/o Sri Ramjanam Singh, R/o 98/ 217, Himmatganj, Allahabad, for Rs. 19,00,000/-, as requested, subject to the conditions that he should submit the relevant papers of the transaction after its completion?
