Provided that any such transaction conducted otherwise than through a regular & reputed dealer shall require the previous sanction of the appropriate authority."

It is further submitted that the officer had already been granted permission to sell the said property, vide Court's order dated 16.02.2012 (flag 'X'), to an other earlier proposed purchaser namely Sri Surendra Nath Singh. Now, it is stated by the officer that the said purchaser Sri Surendra Nath Singh has requested him that on account of certain unavoidable circumstances the sale deed may be executed in favour of his nominee i.e. Smt. Vandana Verma, W/o Dr. Rakesh Verma, R/o Vinayak Complex, 21/17, Elgin Road, Civil Lines, Allahabad. The officer has, therefore, requested for grant of permission to sell the same property to Smt. Vandana Singh now.
