May kindly see the letter dated 02.05.2012, placed at flag 'A', received from Hon'ble Mr. Justice M. Karpaga Vinayagam, Chairperson, Appellate Tribunal for Electricity, New Delhi, which is addressed to Hon'ble The Chief Justice of this Court, regarding grant of permission to Shri Harvir Singh, an officer of Uttar Pradesh Higher Judicial Service, presently posted as Registrar on deputation in Appellate Tribunal for Electricity, to visit abroad.

In the letter, Hon'ble Mr. Justice M. Karpaga Vinayagam has stated that Shri Harvir Singh, an officer of Uttar Pradesh Higher Judicial Service, is presently posted as Registrar on deputation in Appellate Tribunal for Electricity. As Chairperson of the Tribunal, His Lordship has nominated Hon'ble Members as well as Registrar to attend a Seminar of Electricity Regulators at Florida, USA to be held between 28th July' 2012 and 5th August' 2012. Their attending the said Seminar would be beneficial and in the interests of the Tribunal. The said visit is sponsored by the Government of India and the entire expenditure would be borne by the Tribunal itself. In the light of the above, His Lordship has stated that Shri Harvir Singh may be granted permission to visit abroad.

In this connection, it is submitted that the proposed visit of the officer Shri Harvir Singh, Registrar, Appellate Tribunal for Electricity, New Delhi is purely official and, when Hon'ble The Chairperson, Appellate Tribunal for Electricity, New Delhi has himself intimated about his proposed visit to USA in connection with attending Seminar of Electricity Regulators at Florida, USA to be held between 28th July' 2012 and 5th August' 2012 and has written the instant letter for grant of permission to Shri Harvir Singh for the purpose, there seems to be nothing objectionable.
