In the letter, Shri Harvir Singh has stated that he is presently posted as Registrar on deputation in Appellate Tribunal for Electricity, New Delhi and has been nominated by Hon'ble The Chairperson, Appellate Tribunal for Electricity, to visit Amsterdam & Paris (France) & U.K. between 10th July & 20th July, ²⁰¹⁴ The purpose of visit is official and in the interest of the Tribunal and the entire expenditure including to & fro journey etc. shall be borne by the Tribunal itself as per Rules. He has also enclosed copy of authorization/ note dated 23.05.2014 (flag 'Y') and submitted that his request may kindly be placed before Hon'ble the Court for according sanction to visit abroad, as stated above.

In this connection, it is submitted that the proposed visit of the officer Shri Harvir Singh, Registrar, Appellate Tribunal for Electricity, New Delhi is purely official and as Hon'ble The Chairperson, Appellate Tribunal for Electricity, New Delhi has already nominated him for the proposed visit to Amsterdam & Paris (France) & U.K. in connection with participation in Power Market Study Tour 2014, there seems to be nothing objectionable. Earlier also in the year 2012, Shri Singh had applied for grant of permission of similar type of official tour to USA, vide his letter dated 02.05.2012 (flag 'X'), as well as Hon'ble Mr. Justice M. Karpaga Vinayagam, Hon'ble The Chairperson, Appellate Tribunal of Electricity, New Delhi has also written a Demi official letter dated 02.05.2012 (flag 'A') to Hon'ble The Chief Justice, High Court of Judicature at Allahabad, Allahabad in this regard, which was submitted before Hon'ble The Chief Justice through office note dated 08.05.2012 (flag 'XX'), upon which His Lordship had been pleased to grant permission to the officer.
