Kindly refer to your letter No. 8937/IV-3519/Admin (A)/Dated 7/7/2015 and to convey that I joined the service on 15/12/2008 and the property statement as on the date of joining of service i.e 15/12/2008 has already been submitted to Hon'ble High Court and the property statement for the financial year 2011-2012 i.e as on 31/3/2012 has also been submitted to the Hon'ble High Court. 


