May kindly see the letter dated 20.4.17 (flagged 'A') by which Sri Harvir Singh, Additional District and Sessions Judge, Hardoi has submitted his movable and immovable property statement for the financial years 2015-16 and 2016-17.

Earlier Sri Singh has submitted his property statement for the financial year 2014-15 vide his letter dated 22.12.15(flag 'B') but he has not submitted his property statement for the financial year 2015-16, hence a Court letter dated 4.2.2016(flag 'C') has been sent to the officer in this regard.

In reply of aforesaid Court's letter, Officer vide his letter dated 20.4.17(flag 'A') has submitted his property statement for the financial years 2015-16 and 2016-17 but as per Circular letter dated 13.5.04, property statement for the financial year 2016-17 alongwith property statement for the financial year 2017-18 will be due in the financial year 2018-19.

In this connection, it is submitted that as per statement of movable and immovable property for the financial years 2014-15 and 2015-16 of the officer concerned, details of income, deductions, Savings, investment and expenditure made by him are given below.

(1) In the financial year 2014-15, Sri Singh's Total Gross Income from Salary is Rs.16,90,846/- from this amount Rs.2,45,000/- against Income Tax, Rs.1,42,460/- against PF, Rs.6,84,000/- towards home loans, Rs.60,551/- against LIC. The balance of his Saving Bank Account(s) has enhanced for Rs.51,750/- in this year against the balance of previous year. As such, total deductions /repayment/Savings/investment is Rs.11,83,761/-. Thus a sum of Rs.5,07,085/- was therefore available with him to meet out the household expenditure of his family consisting of four members in the financial year 2014-15.

(2) In the financial year 2015-16, Sri Singh's Total Gross Income from Salary is Rs.15,65,634/- from this amount Rs.800/- against GIS, Rs.2,66,900/- against Income Tax, Rs.1,31,658/- against PF, Rs.6,84,000/- towards home loans, Rs.60,551/- against LIC. The balance of his Saving Bank Account(s) has enhanced for Rs.1,48,412/- in this year against the balance of previous year. As such, total deductions /repayment/Savings/investment is Rs.12,92,321/-. Thus a sum of Rs.2,73,313/- was therefore available with him to meet out the household expenditure of his family consisting of four members in the financial year 2015-16.

The movable and immovable property statement for the financial years 2014-15 has been sent by the officer vide his letter dated 22.12.15(flag 'B') and property statement for the financial year 2015-16 has been submitted by the officer vide his letter dated 20.4.17 (flagged 'A'). The property statements for the financial years 2014-15 and 2015-16 was due to be submitted in third financial years 2016-17 i.e. on or before 31.3.17. As such there is some delay in submitting the property statement for the financial year 2015-16 from the part of the officer.

In this connection it is submitted that wife of the officer Smt. Babita Rani is

working with CBSE, Ministry of HRD, Central Govt.

In this connection it is submitted Sri Singh had already submitted his property statement upto financial year 2013-14 which had already been seen by Hon'ble the Chief Justice on 14.9.15, which is at flag 'Z' and the said statement at flag 'M'.

May, if approved, the statements of movable and immovable property for the financial years 2014-15 and 2015-16 of Sri Harvir Singh, Additional District and Sessions Judge, Hardoi may kindly be laid before Hon'ble Mr Justice Mahendra Dayal, Administrative Judge, Hardoi Judgship for His Lordship's kind perusal and orders?
