1. शरीर के मापदण्ड के माप (2) शरीर के मापदण्ड

3- उम्मीदवार की लम्बाई इस प्रकार नापी जायेगी। वह अपने जूते उतारेगा और मापदण्ड (Standard) के सामने अपने दोनों पैर मिलाकर तथा एड़ियों के बल खड़ा होगा, न कि अंगूठों या पैर में बाहर की ओर देकर खड़ा होगा। वह स्वाभाविक रूप से सीधा खड़ा होगा और एड़ियाँ, पिडलियाँ, चूतड़ और कंधे मापदण्ड को स्पर्श करे। टडडी को इस प्रकार नीचे किया जायेगा कि सिर के धरातल का सबसे ऊँचा भाग मापदण्ड के हारिजटल-बार के नीचे लगा रहे और न० को माप इन्चों में और इन्च के चौथाई भाग में लिखी जायेगी। इण्डियन पुलिस फोर्स के लिए कम से कम 5 फुट 8 इन्च की लम्बाई आवश्यक है, लेकिन अन्य विभागों में लम्बाई की कोई निर्धारित सीमा नहीं रखी गई है।
