May kindly see the letter dated 23.5.13 (flagged 'A') received from Sri Rajeev Bharti. Additional Director(Training), J.T.R.I., Lucknow by which he has submitted his movable and immovable property statement for the financial years 2008-09, 2009-10, 2010-11 and 2011-12 in prescribed proforma to this Court for kind perusal and orders as required by the Court.

Earlier Sri Bharti has submitted his aforesaid property statement vide his letter dated 7.3.13(flagged 'B') but the same was not in proforma then a Court's letter dated 22.4.13(flagged 'C') was sent to the officer in this regard to the officer.

In reply officer has submitted his aforesaid property statement in Proper proforma vide his letter dated 23.5.13(flagged 'A').

In this connection it is submitted that from perusal of the aforesaid property statement it appears that in financial year 2008-09 Sri Bharti total income from salary and other resources is Rs.1,51,094/- from this amount he has subscribed /deposited Rs.97000/- in Saving Bank Account, Rs.24000/- in R.D. And Rs.58,853/- in Insurance . The Total deductions and investment is Rs.1,59,853/-. His wife income (annual) from Rent of her plots and Stridhan gifts from her parents brothers and relatives is Rs.1,50,000/- as shown in the aforesaid property statement by the officer is available to him to meet out his family expenditure in whole year.

In Financial year 2009-10 Sri Bharti total income from salary is Rs.5,12,805/- from this amount he has subscribed /deposited total Rs.41,400/- in PPF, Rs.1000/- in UTI, Rs.58853/- in Insurance/-, Rs.24000/- in R.D. Account and Rs.1000/- in Kisan Vikas Patra. The Total deductions and investment is Rs.1,26,253/-. Thus a sum of Rs.3,86,552/- was therefore available to him to meet out his family expenditure in whole year.

In the financial year 2010-11, Sri Bharti total income from salary is Rs.9,50,489/- from this amount he has subscribed /deposited total Rs.23000/- in different Bonda,, Rs.1,60,000/- in Sazvingh Bank Account, RS.1,47,679/- in PPF, Rs.23365/- in CPF, Rs.75,000/- in NSC and Rs.24000/- in RD account. The Total deductions and investment is

Rs.4,53,044/- /-. Thus a sum of Rs.4,97,445/- /- was therefore available to him to meet out his family expenditure in whole year.

In the financial year 2011-12, Sri Bharti total income from salary is Rs.10,44,922/- from this amount he has subscribed /deposited total Rs.29000/- in PPF, Rs.40,000/- in CPF, Rs.54,650/- in PLI and RS.s1,40,000/- in different Bonmds. The Total deductions and investment is Rs.2,63,650/-/-. Thus a sum of Rs.9,39,272/- was therefore available to him to meet out his family expenditure in whole year.

The aforesaid movable and immovable property statement for the financial years 2008-09, 2009-10, 2010-11 and 2011-12 has been submitted by the officer vide his letters dated 7.3.13(flagged 'A') which was due to be submitted in third financial years 2010-11 and 2011-12 i.e. on or before 31.3.11 and 31.3.13. As such there appears some delay in submitting the property statement for the financial year 2008-09 and 2009-10 which was to submitted on or before 31.3.11.

In this connection it is submitted that Sri Bharti has already submitted his property statement at the time of entering into Judicial Service which has already been seen by Hon'ble Mr. Justice Shri Narayan Shukla, Administrative Judge, Kheri Judgeship on 6.7.10 which is at flag 'Z'. The said statement for financial year 2005-06 is at flag 'M'.

May, if approved, the statements of movable and immovable property for the financial years 2008-09, 2009-10, 2010-11 and 2011-12 of Sri Rajeev Bharti. Additional Director(Training), J.T.R.I., Lucknow be laid before Hon'ble Mr. Justice Rakesh Tiwari, Administrative Judge, Lucknow Judgeship for His Lordship's kind perusal and orders?
