May kindly see the application dated 25.08.2010 of Sri Rajeev Bharti, Special Judge/ Additional District Judge, Lakhimpur Kheri through which he has submitted declaration (two)duly filled up alongwith attested copies of certificate relating to age proof of his children and attested copy of Green Card, to this Court regarding grant of personal pay under voluntary family planning programme, in terms of G.O. Pa.Ka. 4601/16-11-79-9/155/79, dated 23.02.1980 placed below at Flag 'A'.

It may be recalled that earlier Sri Rajeev Bharti, sent an application dated 18.08.2009 and applied for personal pay but he did not submitted declaration with his application dated 08.08.2009 as required under the rule. Therefore a Court's letter no.16544/IV-3534/ Admin A/ dated 07.12.2009 was sent to the District Judge, Lakhimpur Kheri alongwith format of declaration (two) regarding grant of personal pay under voluntary family planning programme with a the request to ask Sri Rajeev Bharti, to resubmit the same duly filled up in all respects alongwith attested copies of birth certificates of his children to this Court for necessary action.

In a reply of Court's letter dated 07.12.2009 Sri Rajeev Bharti, has submitted declaration alongwith attested copies of certificate of age proof of his children through his letter dated 25.08.2010, to this Court for necessary action.

According to papers received from Sri Rajeev Bharti, dated 25.08.2010, 18.08.2009 and papers available on his instant personal / Misc. file details of the claim are as under:-

- 1. His date of birth is 21.01.1971
- 2. His present age is 39 years 7 month as per declaration
- 3. He joined the service on 15.12.2008
- 4. He has two children vide declaration at flag ' *B' >
- 5. He has stearlised his wife on 05.02.2009 at Sanawar Hospital, Deoband, Saharanpur. He has submitted attested copy of Green Card iand attested copy of birth certificate of his second child which are at flag D and E
- 6. He has not got the personal Pay under voluntary family planning programme vide declaration at flag 4 3
- 7. His wife is alive. She is not a government servant and she is not getting said benefit vide declaration at flag 6 8
- 8. Neither any departmental enquiry is pending against Sri Rajeev Bharti, Special Judge/ Additional District Judge, Lakhimpur Kheri nor he has been punished by stoppage of increment and he has not been suspended in connection with such enquiry as reported by Section Officer (Confidential-A) section at flag 6 F.

In terms of G.O. Pa.Ka. 1683/16-11-80-9/155/79, dated 26.05.1980 and G.O. Mo-Pa.Ka. 2667/16-11-80-9/155/79, dated 11.06.1980 required declaration have been furnished by Sri Rajeev Bharti, and same are at flag $^{\circ}$ $^{\circ}$ $^{\circ}$ $^{\circ}$ $^{\circ}$

In this connection it is submitted that Sri Rajeev Bharti, Special Judge/ Additional District Judge, Lakhimpur Kheri has got stearlised his wife on 05.02.2009 and he has fulfilled all the conditions as laid down in the aforesaid G.Os for saintion of personal pay under voluntary family planning programme. Therefore, he is entitled to get the benefit of personal pay under voluntary family planning programme equal to one increment with effect from 05.02.2009.
