Sir,

With reference to your endt no. 1171/I dated 25.05.2017 on the above subject, I have
to say that Sri Anil Kumar Verma, Principal Judge, Family Court, Etawah may kindly be
informed that earlier he had applied for permission to purchase pistol & rifle both, upon which
Hon'ble Court had granted permission to purchase a Pistol whereas permission to purchase
a Rifle was refused. The officer has again applied for grant of permission to purchase a rifle,
and after reconsidering his request, Hon'ble Court has passed an order that:

**"The officer concerned has already purchased a pistol. Now he wants to
purchase a rifle. Why so many firearms are required by him, no justification has come
forward in this regard. Every Judicial officer has to discharge same kind of work and
has same service conditions as others have. There is nothing special with this Officer,
and none has been pointed out by him. I do not find any reason for reconsideration of
earlier order whereby his request was rejected."**

The abovementioned order was already communicated to the officer. Now, he has
freshly applied for grant of permission to purchase a rifle again, but as there is no justification
for acquiring so many firearms and as there is nothing special which has been pointed out by
him further, his request appears to be not entertainable.

Sri Verma, may kindly be informed accordingly.






