May kindly see the property statement submitted online dated 21.05.2020 received from Sri Syed Maooz Bin Asim, Registrar (J) (Nazarat), High Court, Lucknow Bench, Lucknow regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial year 2016-17 & 2017-18 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court. In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2016-17 & 2017-18 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial year 2016-17 & 2017-18, income from salary is Rs.33,94,139/- and total deductions/ repayment/ savings/ investment (for both the financial years) against NPS, GIS, Income Tax, LIC policies and the balance of his savings bank account(s) is enhanced for Rs.8,93,773/- this financial year from previous year's balance, total of which is Rs.22,51,959/-. Thus, a sum of Rs.11,42,140/- was therefore available with him to meet out the household expenditure of his family consisting four members in both the financial years.

In this connection, it is submitted that Sri Syed Maooz Bin Asim has already submitted his property statement upto the financial year 2013-14, which had already been seen by Hon'ble Mr. Justice Prashant Kumar, the then Administrative Judge, Sitapur in the misc. file of the officer and of the financial years 2014-15 & 2015-16 are currently processed online & a separate note has been made on case-id no.1005.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement of the financial years 2016-17 & 2017-18 in its next financial year i.e., 2018-19 upto March 2019. He has submitted movable and immovable property statements of the financial years 2016-17 & 2017-18 vide online dated 21.05.2020. As such, there is delay in submitting the same from the part of the officer for which he has stated that due to some personal

problems and heavy rush of work undersigned unknowingly forgot the schedule of submitting the property statement before the Hon'ble Court. Due to this reason, property statement for the financial year 2016-17 & 2017-18 could not be submitted on time, which is deeply regretted, in column no.9 of the statements.

May, therefore, if approved, property statements of the financial year 2016-17 & 2017-18 of Sri Syed Maooz Bin Asim, Registrar (J) (Nazarat), High Court, Lucknow Bench, Lucknow be laid before Hon'ble the Chief Justice for His Lordship's kind perusal and orders?
