May kindly see the online 28.05.2020 received from Sri Harendra Nath, Judge, Small Causes Court, Allahabad regarding submission of statements of movable and immovable properties for the financial years 2015-16 and 2016-17 on proforma to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statements of movable and immovable properties for the financial years 2015-16 and 2016-17 of the Officer concerned, details of income, deductions, savings, investment and expenditure made by him are given below.

1. In the financial year 2015-16 and 2016-17, his gross income from salary is Rs. 17,89,171/- and total deductions/Savings/investments against NPS, GIS, income tax, Loan-repayment, insurances and PPF is Rs. 8,17,321/-. Thus a sum of Rs.9,71,850/- was therefore available with him to meet out the household expenditure of his family consisting of four members in the financial year 2015-16 and 2016-17. The balance of Rs.49,948/- has decreased from his saving bank A/c against the balance of the previous year.

It is pertinent to mention that the wife of the officer, Smt. Amita Rajput is a Dental Surgeon whose monthly income is Rs.20,000/- in the financial years 2015-16 and 2016-17.

In this connection it is submitted that the officer has already submitted his property statements upto the financial year 2014-15 which has already been seen by Hon'ble Mr. Justice Manoj Kumar Gupta, the then Administrative Judge, Shahjahanpur in the Misc. file of the officer.

The movable and immovable property statement for the financial years 2015-16 and 2016-17 have been submitted by the Officer vide his online case id no. 1018 dated 28.05.2020 which was due to be submitted upto the end of the financial year 2017-18. As such, there is delay in submitting the property statements from the part of the officer.
