May kindly see the property statement submitted online dated 16.06.2020 received from Sri Ajay Kumar Tripathi-II, Additional Principal Judge, Family Court, Pratapgarh regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial years 2018-19 & 2019-20 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2018-19 & 2019-20 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial years 2018-19 & 2019-20, income from salary & other sources (of both the financial years) are Rs.42,35,231/- and total deductions/ repayment/ savings/ investment against GPF, Income Tax, LIC, PPF a/c, Home Ioan, PLI, ITGI and paid from salary against Flat (mentioned in the misc. file) are Rs.45,04516/-. The balance of his savings bank account(s) also reduced for Rs.13,42,650/- this financial year from previous year's balance. Thus, a sum of Rs.10,73,365/- was therefore available with him to meet out the household expenditure of his family consisting four members for both the financial years 2018-19 & 2019-20.

It is pertinent to mention here that his elder daughter appointed as Additional Civil Judge (Jr. Div.) on 16.11.2019 at Pratapgarh, U.P.

In this connection it is submitted that for the preceding year, he has submitted his property statement upto the financial year 2017-18, which has already been seen by Hon'ble Mr. Justice Rajesh Dayal Khare, the then Administrative Judge, Aligarh in the mlsc. file of the officer.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2018-19 & 2019-20 in its next financial year i.e., 2020-21 upto March 2021. He has submitted movable and immovable property statements of the financial year 2018-19 & 2019-20 vide online dated

16.06.2020. As such, there is no delay in submitting the same from the part of the officer.

May, therefore, if approved, property statements for the financial year 2018-19 & 2019-20 of Sri Ajay Kumar Tripathi-II, Additional Principal Judge, Family Court, Pratapgarh be laid before Hon'ble Ms. Justice Naheed Ara Moonis, Administrative Judge, Pratapgarh Judgeship for Her Lordship's kind perusal and orders?
