May kindly see the property statements submitted online dated 30.05.2020 received from Sri Durg Narain Singh, Additional District & Sessions Judge, Lucknow regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial year 2018-19 & 2019-20 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2018-19 & 2019-20 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial year 2018-19 & 2019-20, Gross income from salary (both the financial years) is Rs.52,20,342/- (including Agricultural income of Rs.6,54,000/-) and total deductions/ repayment/ savings/ investment against GPF, GIS, Income Tax, LIC policies, SIP, PPF a/cs and the balance of his savings bank account(s) is enhanced for Rs.5,45,760/- this financial year from previous year's balance, total of which is Rs.27,99,679/-. Thus, a sum of Rs.24,20,666/- was therefore available with him to meet out the household expenditure of his family consisting four members in both the financial years 2018-19 & 2019-20.

In this connection it is submitted that the officer has already submitted his property statement upto the financial year 2017-18 which had already been seen by Hon'ble Mr. Justice Rajan Roy, the then Administrative Judge, Lucknow in the misc. file of the officer.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2018-19 & 2019-20 in its next financial year i.e., 2020-21 upto March 2021. He has submitted movable and immovable property statements of the financial year 2018-19 & 2019-20 vide online dated 30.05.2020. As such, there is no delay in submitting the same from the part of the officer.
