May kindly see the online request dated 03.06.2020 received from Sri Ashish Garg, Registrar (J) Listing, Allahabad High Court, Allahabad regarding submission of statements of movable and immovable properties for the financial years 2018-19 and 2019-20 proforma to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statements of movable and immovable properties for the financial years 2018-19 and 2019-20 of the Officer concerned, details of income, deductions, savings, investment and expenditure made by him are given below.

1. In the financial year 2018-19 , his gross income from salary and other sources is Rs. 52,13,535/- (Rs.28,16,373/- from Salary, Rs. 14,400/- from House Rent, Rs. 10,30,166/- from interest, Rs.32,109/- from KVP and Rs. 13,20,487/- from FD) and total deductions/Savings/investments against NPS, GIS, Income Tax, PPF, FD, insurances and KVP is Rs. 55,81,728/-. The balance of Rs. 13,19,105/- has decreased from his saving bank a/cs against the balance of the previous year. Thus a sum of Rs. 9,50,912/- was therefore available with him to meet out the household expenditure of his family consisting of four members in the financial year 2018-19.
2. In the financial year 2019-20 , his gross income from salary and other sources is Rs. 40,86,037/- (Rs. 25,39,770/- from salary, Rs. 14,400/- from House Rent, Rs. 11,56,642/- from interest, Rs. 3,29,583/- from FD and Rs. 45,642/- from NSC) and total deductions/Savings/investments against NPS, GIS, Income Tax, PPF, FD, insurances, KVP and NSC is Rs.27,53,673/- (including enhancement of Rs. 1,94,663/- in his saving bank A/cs against the balance of the previous year). Thus a sum of Rs.13,32,364/- was therefore available with him to meet out the household expenditure of his family consisting of four members in the financial year 2019-20.

In this connection it is submitted that Sri Singh has already submitted his property statements upto the financial year 2017-18 which have already been seen by Hon'ble the then Acting Chief Justice in the miscellaneous file of the Officer.

The movable and immovable property statement for the financial year 2018-19 and 2019-20 have been submitted by the Officer vide his online case id no. 1045 dated 03.06.2020 which is due to be submitted upto the end of the financial year 2020-21 as per two year block policy. As such, there is no delay in submitting the property statements from the part of the officer.

May, if approved, the movable and immovable property statements for the financial years 2018-19 and 2019-20 of Sri Ashish Garg, Registrar (J) Listing, Allahabad High Court, Allahabad be laid before Hon'ble the Chief Justice, High Court, Allahabad for His Lordship's kind perusal and orders?
