May kindly see the property statements submitted online dated 12.06.2020 received from Sri Padmakar Mani Tripathi, Special Judge (SC/ST, Pev. Of Atroci Act), Lucknow regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial year 2016-17 & 2017-18 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2016-17 & 2017-18 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial year 2016-17 & 2017-18, Gross income (for both the financial years) is Rs.32,07,335/- and total deductions/ repayment/ savings/ investment (for both the financial years) against GIS, GPF, Income Tax, LIC policies, PPF a/c, RD, Car loan, Home loans and the balance of his savings bank account(s) is enhanced for Rs.8,17,926/- this financial year from previous year's balance, total of which is Rs.22,37,340/-. Thus, a sum of Rs.9,69,995/- was therefore available with him to meet out the household expenditure of his family consisting four members in both the financial years.

In this connection it is submitted that the officer has already submitted his property statement upto the financial year 2015-16 which had already been seen by Hon'ble Mr. Justice Rajan Roy, the then Administrative Judge, Lucknow in the misc. file of the officer.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial year 2016-17 & 2017-18 in its next financial year i.e., 2018-19 upto march 2019. He has submitted property statements for the financial years 2016-17 & 2017-18 vide online dated 12.06.2020. As such, there is delay in submitting the aforesaid property statement from the part of the officer.
