May kindly see the property statement submitted online dated 03.06.2020 received from Sri Dhruva Kumar Tiwari, Principal Judge, Family Court, Siddharth Nagar regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial year 2014-15 & 2015-16 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2014-15 & 2015-16 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial years 2014-15 & 2015-16, total income is Rs.38,19,179/- (income from salary is Rs.31,55,097/-, received matured amount of PPF, RD & LIC are Rs.5,21,784/-, Rs.1,15,498/- & Rs.26,800/- respectively) and total deductions/ repayment/ savings/ investment (for both the financial years) against GIS, GPF, Income Tax, LIC, RD and the balance of his savings bank account(s) is enhanced for Rs.41,275/- this financial year from previous year's balance, total of which is Rs.11,85,266/-. Thus, a sum of Rs.26,33,913/- was therefore available with him to meet out the household expenditure of his family consisting four members in both the financial years.

It is pertinent to mention here that his wife as an Advocate earns Rs.6,000/- to Rs.8,000/- per month.

In this connection, it is submitted that Sri Dhruva Kumar Tiwari has already submitted his property statement upto the financial years 2009-10 which had already been seen by Hon'ble Mr. Justice Shyam Shankar Tiwari, the then Administrative Judge, Chandauli in the misc. file of the officer. And of the financial years 2010-11 & 2011-12 and 2012-13 & 2013-14 are currently processed & separate notes has made on case-id no.1049 and 1047 respectively.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement of the financial years 2014-15 & 2015-16 in its next financial year i.e., 2016-17 upto March 2017. He has submitted movable and immovable property statements of the financial years 2014-15 & 2015-16 vide online dated 03.06.2020. As such, there is delay in submitting the same from the part of the officer for which he has highly regretted for not being able to send his Property Statements in time and stated that he could not send his Property Statements due to some inevitable circumstances & domestic problems in the past years and it became extremely delayed. He has also humbly request good-self's mercy for condoning the delay and kindly accepting his Property Statements for which he shall be highly obliged and be ever grateful (mentioned in remark column).

May, therefore, if approved, property statements of the financial year 2014-15 & 2015-16 of Sri Dhruva Kumar Tiwari, Principal Judge, Family Court, Siddharth Nagar be laid before Hon'ble Mr. Justice Ashwani Kumar Mishra, Administrative Judge, Siddharthnagar Judgeship for His Lordship's kind perusal and orders?
