May kindly see the property statements submitted online dated 05.06.2020 received from Sri Harendra Bahadur Singh, Special Judge (Pre. Cor. Act), Lucknow regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial years 2016-17 & 2017-18 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2016-17 & 2017-18 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial years 2016-17 & 2017-18, Gross income from salary (of both the financial years) is Rs.32,99,971/- and total deductions/ repayment/ savings/ investment (for both the financial years) against GIS, GPF, Income Tax, PPF a/c and Personal loans are Rs.17,23,918/-. Thus, a sum of Rs.15,76,053/- was therefore available with him to meet out the household expenditure of his family consisting four members in both the financial years. And the balance of his savings bank account(s) is also reduced for Rs.2,11,433/- this financial year from previous year's balance.

In this connection, it is submitted that the officer has already submitted his property statement upto the financial year 2015-16 which has already been seen by Hon'ble Mr. Justice K.N.Bajpayee, the then Administrative Judge, Faizabad in the misc file of the officer.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2016-17 & 2017-18 in its next financial year i.e., 2018-19 upto March 2019. He has submitted movable and immovable property statements for the aforesaid financial years vide online dated 05.06.2020. As such, there is delay in submitting the same from the part of the officer for which he has stated that due to some misconception, there is a delay in submission and requested to condone the delay in his letter

dated 06.06.2020 (attached Delay Condonation application with the statements)

May, therefore, if approved, property statements for the financial years 2016-17 & 2017-18 of Sri Harendra Bahadur Singh, Special Judge (Pre. Cor. Act), Lucknow be laid before Hon'ble Mr. Justice Ritu Raj Awasthi, Administrative Judge, Lucknow Judgeship for His Lordship's kind perusal and orders?
