May kindly see the online letter 07.06.2020 received from Sri Sunil Kumar Verma, Special Judge (SC/ST Prev. of Atroci. Act), Bareilly regarding submission of statements of movable and immovable properties for the financial years 2018-19 and 2019-20 on proper proforma to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statements of movable and immovable properties for the financial years 2018-19 and 2019-20 of the Officer concerned, details of income, deductions, savings, investment and expenditure made by him are given below.

1. In the financial years 2018-19 and 2019-20, his gross income from salary and other sources is Rs. 66,03,940/- (Rs. 47,97,485/- from salary, RS.18,183/-from Electricity reimbursement, Rs. 2,00,000/- from Agriculture, Rs. 1,15,619/- from petrol reimbursement, Rs. 14,24,297/- from PPF maturity and Rs.48,356/- from S.B. interest) and total deductions/Savings /investments against GPF, GIS, Income Tax, Loan-repayment, PPF, FD and Insurances is Rs.33,95,277/- (including enhancement of balance of Rs. 1,01,913/- in his saving bank A/c against the balance of the previous year). Thus a sum of Rs. 32,08,633/- was therefore available with him to meet out the household expenditure of his family consisting of four members in the financial years 2018-19 and 2019-20.

In this connection it is submitted that the officer has already submitted his property statements upto the financial year 2015-16 which has already been seen by Hon'ble Mr. Justice S.N. Shukla, the then Administrative Judge, Bulandshahar in the in the Misc. file of the officer.

For the preceding financial years, the officer has submitted his property statements for the financial years 2016-17 and 2017-18 which have been processed presently online and separate office note has already been submitted for orders on separate case id no. 1021.

The movable and immovable property statement for the financial years 2018-19 and 2019-20 have been submitted by the Officer vide his online case id no. 1080 dated 07.06.2020 which were due to be submitted upto the end of the financial year 2020-21. As such, there is no delay in submitting the property statements from the part of the officer.
