May kindly see the property statement submitted online dated 07.06.2020 received from Sri Ram Nagina Yadav, Additional Director (Training), Lucknow regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial years 2018-19 & 2019-20 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2018-19 & 2019-20 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial year 2018-19 & 2019-20, Gross income (of both the financial years) are Rs.68,79,497/- and total deductions/ repayment/ savings/ investment against GPF, GIS, Income Tax, Education loan, Home Loan, Car loan, PPF a/c, wife's PPF a/c, LIC and Mutual funds are Rs.36,69,962/-. Thus, a sum of Rs.32,09,535/-was therefore available with him to meet out the household expenditure of his family consisting seven members for both the financial years 2018-19 & 2019-20. And the balance of his savings bank account(s) is also reduced for Rs.223/- this financial year from previous year's balance.

In this connection it is submitted that for the preceding year, he has submitted his property statement upto the financial year 2017-18, which has already been seen by Hon'ble Mr. Justice Rajan Roy, the then Administrative Judge, Lucknow, in the mlsc. file of the officer.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial year 2018-19 & 2019-20 in its next financial year i.e., 2020-21 upto March 2021. He has submitted movable and immovable property statements of the financial years 2018-19 & 2019-20 vide online dated 07.06.2020. As such, there is no delay in submitting the same from the part of the officer.
