May kindly see the online 09.06.2020 received from Sri Raj Babu, Addl. Chief Judicial Magistrate, Bulandshahar regarding submission of statements of movable and immovable properties for the financial years 2014-15 and 2015-16 proforma to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statements of movable and immovable properties for the financial years 2014-15 and 2015-16 of the Officer concerned, details of income, deductions, savings, investment and expenditure made by him are given below.

1. In the financial year 2014-15 (28.01.2015 to 31.03.2015, his gross income from salary is Rs. 68,068/- and total deductions/Savings/investments against GIS is Rs. 400/-. Thus a sum of Rs. 67,668/- was therefore available with him to meet out the household expenditure of his family consisting of one member in the financial year 2014-15. The balance of Rs. 1,829/- has decreased from his saving bank A/c against the balance of the previous year.
2. In the financial year 2015-16, his gross income from salary is Rs. 7,58,614/- and total deductions/Savings/investments against NPS, GIS, Income Tax, PPF, loan- repayment and insurances is Rs. 2,18,221/-. Thus a sum of Rs. 5,40,393/- was therefore available with him to meet out the household expenditure of his family consisting of two members in the financial year 2015-16. The balance of Rs. 3,678/- has decreased from his saving bank A/c against the balance of the previous year.

In this connection it is submitted that the officer has already submitted his property statements held at the time of entering U.P. Judicial Services which has already been seen by Hon'ble Ms. Bharati Sapru, the then Administrative Judge, Sultanpur in the Misc. file of the officer.

The movable and immovable property statement for the financial years 2014-15 and 2015-16 have been submitted by the Officer vide his online case id no. 1095 dated 09.06.2020 which was due to be submitted upto the end of the financial year 2016-17. As such, there is delay in submitting the property statements from the part of the officer and he has apologized for the delay caused.

May, if approved, the movable and immovable property statements for the financial years 2014-15 and 2015-16 of Sri Raj Babu, Addl. Chief Judicial Magistrate, Bulandshahar be laid before Hon'ble Mr. Justice Ramesh Sinha, Administrative Judge, Bulandshahar Judgeship for His Lordship's kind perusal and orders?
