May kindly see the property statement submitted online dated 05.12.2020 received from Sri Vivek Kumar, Additional District Judge (POCSO), Pilibhit regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial years 2018-19 & 2019-20 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2018-19 & 2019-20 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial years 2018-19 & 2019-20, income from salary (for both the financial years) is Rs.35,32,888/- and total deductions/ repayment/ savings/ investment against NPS, GIS, Income Tax, Car loan and Insurance policies are Rs.15,31,908/-. Thus, a sum of Rs.20,00,980/- was therefore available with him to meet out the household expenditure of his family consisting three members for both the financial years 2018-19 & 2019-20. And the balance of his savings bank account(s) is also reduced for Rs.24,101/- this financial year from previous year's balance.

It is pertinent to mention here that his wife earns approx. Rs.3,50,000/- per annum and Rs.4,00,000/- per annum from Private Tutions and online guest lecture to D.V.S. Academy Meerut in the financial years 2018-19 & 2019-20 respectively.

In this connection it is submitted that he has already submitted his property statement at the time of joining into U.P. Higher Judicial Service which has already been seen by Hon'ble Mr. Justice Virendra Kumar-II, the then Administrative Judge, Pilibhit with the order that the officer is advised to submit his statement of movable & immovable property strictly in future in accordance with circular issued by this Court.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years

2018-19 & 2019-20 in its next financial year i.e., 2020-21 upto March 2021. He has submitted movable and immovable property statements of the financial years 2018-19 & 2019-20 firstly vide online dated 05.10.2020. As such, there is no delay in submitting the same from the part of the officer.

May, therefore, if approved, property statements of the financial years 2018-19 & 2019-20 of Sri Vivek Kumar, Additional District Judge (POCSO), Pilibhit be laid before Hon'ble Mr. Justice Siddhartha Varma, Administrative Judge, Pilibhit Judgeship for His Lordship's kind perusal and orders?
