May kindly see the property statement submitted online on date 11.11.2020 received from Sri Dharam Veer Singh, Additional Civil Judge (Sr. Div.)/ Additional Chief Judicial Magistrate, Meerut regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial year 2017-18 & 2018-19 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2017-18 & 2018-19 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

(1) In the financial year 2017-18 & 2018-19, Total income from salary is Rs.24,35,522/- (including increment arrears since first as well as 30% hike in salary arrears given to him in the financial year 2018-19) and total deductions/ repayment/ savings/ investment (for both the financial years) against GIS, NPS, Income Tax, PPF, Sukanya Samridhi Yojna and the balance of his savings bank account(s) is enhanced for Rs.8,73,828/- this financial year from previous year's balance, total of which is Rs.18,03,908/-. Thus, a sum of Rs.6,31,614/- was therefore available with him to meet out the household expenditure of his family consisting four members in both the financial years.

In this connection, it is submitted that the officer has already submitted his property statement up to the financial year 2016-17 which had already been seen by Hon'ble Mr. Justice Manoj Misra, the then Administrative Judge, Meerut with the warning issued to the officer should be cautioned to be careful in future and not to commit such mistake in the misc. file of the officer.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement of the financial years 2017-18 & 2018-19 in its next financial year i.e., 2019-20 up to March 2020. He has submitted movable and immovable property statements of the financial years 2017-18 firstly vide offline (in the misc. file) dated 25.05.2018 & 2018-19 firstly vide online dated 02.07.2020. As such, there is delay in submitting the property statement of the financial year 2018-19 from the part of the officer for which he in his reply dated 03.10.2020 has stated that- "He was mistakenly under wrong assumption that this time it is to be submitted on 2020. Kindly consider this mistake as a bonafide

error and kindly apologize. He will always attentive in future and shall not repeat this mistake.”

May, therefore, if approved, property statements of the financial year 2017-18 & 2018-19 of Sri Dharam Veer Singh, Additional Civil Judge (Sr. Div.)/ Additional Chief Judicial Magistrate, Meerut be laid before Hon’ble Dr. Justice Kaushal Jayendra Thaker, Administrative Judge, Meerut Judgeship for His Lordship’s kind perusal and orders?
