May kindly see the online 10.06.2020 received from Sri Siyaram Chaurasia, Addl. District and Sessions Judge, Bareilly regarding submission of statements of movable and immovable properties for the financial years 2016-17 and 2017-18 on proforma to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statements of movable and immovable properties for the financial years 2016-17 and 2017-18 of the Officer concerned, details of income, deductions, savings, investment and expenditure made by him are given below.

1. In the financial year 2016-17, his gross income from salary is Rs. 12,70,214/- and total deductions/Savings/investments against CPF, GIS, TDS, LIC and loan- repayment is Rs.5,48,623/-. Thus a sum of Rs. 7,21,591/- was therefore available with him to meet out the household expenditure of his family consisting of four members in the financial year 2016-17. The balance of Rs. 15,541/- has decreased from his saving bank A/c against the balance of the previous year.
2. In the financial year 2017-18, his gross income from salary is Rs. 12,71,996/- and total deductions/Savings/investments against CPF, GIS, TDS, loan-repayment, insurances, and SIP is Rs. 7,77,373/- (including enhancement of balance of Rs. 1,49,338/- in his saving bank A/c against the balance of the previous year). Thus a sum of Rs. 4,94,623/- was therefore available with him to meet out the household expenditure of his family consisting of four members in the financial year 2017-18.

In this connection it is submitted that the officer has already submitted his property statements upto the financial year 2015-16 which has already been seen by Hon'ble Mr. Justice Prashant Kumar, the then Administrative Judge, Barabanki in the in the Misc. file of the officer.

The movable and immovable property statement for the financial years 2016-17 and 2017-18 have been submitted by the Officer vide his online case id no. 1109 dated 10.06.20 which was due to be submitted upto the end of the financial year 2018-19. As such, there is delay in submitting the property statements from the part of the officer for which he has stated that inadvertently the property statements could not be submitted in time and apologised for the delay caused.

May, if approved, the movable and immovable property statements for the financial years 2016-17 and 2017-18 of Sri Siyaram Chaurasia, Addl. District and Sessions Judge, Bareilly be laid before Hon'ble Mr. Justice Alok Singh,
