May kindly see the property statement submitted online dated 02.12.2020 received from Sri Pramod Kumar Singh-II, Additional District & Sessions Judge, Mathura regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial years 2016-17 & 2017-18 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2016-17 & 2017-18 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial years 2016-17 & 2017-18, total income is Rs.29,04,049/- (income from salary is Rs.24,94,937/-, matured amount of LIC & NSC are Rs.60,000/- & Rs.3,49,112/-) and total deductions/ repayment/ savings/ investment (for both the financial years) against NPS, GIS, LIC, PPF and the balance of his savings bank account(s) is enhanced for Rs.2,40,164/- this financial year from previous year's balance, total of which is Rs.12,67,593/-. Thus, a sum of Rs.16,36,456/- was therefore available with him to meet out the household expenditure of his family consisting three members in both the financial years.

In this connection, it is submitted that the officer has already submitted his property statement up to the financial years 2009-10 which had already been seen by Hon'ble Mr. Justice Shri Narayan Shukla, the then Administrative Judge, Lakhimpur Kheri in the misc. file of the officer. And of the financial years 2010-11 & 2011-12, 2012-13 & 2013-14 and 2014-15 & 2015-16 are currently processed & separate notes has made on case-id no. 1126, 1127 and 1128 respectively.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement of the financial years 2016-17 & 2017-18 in its next financial year i.e., 2018-19 up to March 2019. He has submitted movable and immovable property statements

of the financial years 2016-17 & 2017-18 vide online dated 22.06.2020. As such, there is delay in submitting the same from the part of the officer for which he has apologized in his attachment 'covering letter' with the statement of 2010-11 & 2011-12.

May, therefore, if approved, property statements of the financial years 2016-17 & 2017-18 of Sri Pramod Kumar Singh-II, Additional District & Sessions Judge, Mathura be laid before Hon'ble Mr. Justice Mahesh Chandra Tripathi, Administrative Judge, Mathura Judgeship for His Lordship's kind perusal and orders?
