May kindly see the online request dated 18.06.2020 received from Sri Niranjan Chandra Pandey, Registrar (Judicial) (S&A/Seniority), High Court, Allahabad regarding submission of statements of movable and immovable properties for the financial years 2018-19 and 2019-20 on proper proforma to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statements of movable and immovable properties for the financial years 2018-19 and 2019-20 of the Officer concerned, details of income, deductions, savings, investment and expenditure made by him are given below:-

- 1. In the financial year 2018-19, his gross income from salary is Rs. 25,18,065/- and total deductions/Savings/investments against GPF, GIS, Income Tax, Ioan-repayment, Donation, LIC and PPF is Rs. 15,11,217/-. Thus, a sum of Rs. 10,06,848/- was therefore available with him to meet out the household expenditure of his family consisting of four members in the financial year 2018-19. The balance of Rs. 40,336/- has decreased from his saving bank A/Cs against the balance of the previous year.
- 2. In the financial year 2019-20 , his gross income from salary is Rs. 20,24,254/- and total deductions/Savings/investments against GPF, GIS, Income Tax, Ioan-repayment, LIC, PPF is Rs.13,19,237/-. Thus a sum of Rs.7,05,017/- was therefore available with him to meet out the household expenditure of his family consisting of four members in the financial year 2019-20. The balance of Rs. 32,140/- has decreased from his saving bank A/Cs against the balance of the previous year.

In this connection, it is submitted that the officer has already submitted his property statements upto the financial year 2017-18 which have already been seen by Hon'ble the then Chief Justice in the miscellaneous file of the Officer.

The movable and immovable property statement for the financial year 2018-19 and 2019-20 have been submitted by the Officer vide his online case id no. 1140 dated 18.06.2020 which is due to be submitted upto the end of the financial year 2020-21 as per two year block policy. As such, there is no delay in submitting the property statements from the part of the Officer.

May, if approved, the movable and immovable property statements for the financial years 2018-19 and 2019-20 of Sri Niranjan Chandra Pandey,, Registrar (Judicial) (S&A/Seniority), High Court, Allahabad be laid before Hon'ble the Chief Justice, High Court, Allahabad for His Lordship's kind perusal and orders?
