May kindly see the online request dated 24.06.2020 received from Smt. Somprabha Mishra, Registrar (Judicial) (Conf.), Allahabad High Court, Allahabad regarding submission of statements of movable and immovable properties for the financial years 2018-19 and 2019-20 on proforma to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statements of movable and immovable properties for the financial years 2018-19 and 2019-20 of the Officer concerned, details of income, deductions, savings, investment and expenditure made by her are given below.

- 1. In the financial year 2018-19, her gross income from salary, and other sources is Rs. 35,15,835/- (Rs. 32,89,663/- from salary, Rs. 2,23,359/- from RD Maturity and Rs. 2,813/- from MIS interest) and total deductions/Savings/investments against GPF, GIS, Income Tax, PPF, Insurance, FD, RD and Mutual Fund is Rs.19,77,066/-. Thus a sum of Rs.15,38,769/- was therefore available with her to meet out the household expenditure of her family consisting of five members in the financial year 2018-20. The balance of Rs. 10,789/- has decreased from her saving bank A/ c against the balance of the previous year.
- 2. In the financial year 2019-20, her gross income from salary and other sources is Rs. 23,08,090/- (Rs. 23,05,277/- from salary and Rs. 2,813/- from MIS interest) and total deductions/Savings/investments against GPF, GIS, Income Tax, PPF, Insurance, FD, RD and Mutual Fund is Rs.17,69,582/-. Thus a sum of Rs.5,38,508/- was therefore available with her to meet out the household expenditure of her family consisting of five members in the financial year 2019-20. The balance of Rs. 1,69,582/- has decreased from her saving bank A/c against the balance of the previous year.

It is pertinent to mention that the husband of the officer, Sri C.S. Mishra is an ISS, whose annual income is Rs. 22,98,844/- in the F.Y. 2018-19 and Rs. 28,43,168/- in the F.Y. 2019-20.

In this connection it is submitted that the officer has already submitted her property statements upto the financial year 2017-18 which have already been seen by Hon'ble the Chief Justice, High Court, Allahabad in the miscellaneous file of the Officer.

The movable and immovable property statement for the financial years 2018-19 and 2019-20 has been submitted by the Officer vide her online case id no. 1164 dated 24.06.2020 which is due to be submitted upto the end of the financial year 2020-21 as per two year block policy. As such, there is no delay in submitting the property statements from the part of the officer.

May, if approved, the movable and immovable property statements for the financial years 2018-19 and 2019-20 of Smt. Somprabha Mishra, Registrar (Judicial) (Conf.), Allahabad High Court, Allahabad be laid before Hon'ble the Chief Justice, High Court, Allahabad for His Lordship's kind perusal and orders?
