May kindly see the online 27.06.2020 received from Dr. Suresh Kumar, Chief Judicial Magistrate, Auraiya regarding submission of statements of movable and immovable properties for the financial years 2017-18 and 2018-19 on proforma to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statements of movable and immovable properties for the financial years 2017-18 and 2018-19 of the Officer concerned, details of income, deductions, savings, investment and expenditure made by him are given below.

1. In the financial year 2017-18, his gross income from salary is Rs. 15,86,078/- and total deductions/Savings/investments against NPS, GIS, income tax, PPF, LIC, and Tuition fees is Rs. 6,11,480/- (including enhancement of balance of Rs. 10,124/- in his saving bank A.cs against the balance of the previous year). Thus a sum of Rs.9,74,598/- was therefore available with him to meet out the household expenditure of his family consisting of four members in the financial year 2017-18.
2. In the financial year 2018-19, his gross income from salary is Rs. 10,69,689/- and total deductions/Savings/investments against NPS, GIS, income tax, PPF, LIC and Tuition fee Rs.5,26,256/- (including enhancement of balance of Rs. 1,16,513/- in his saving bank A.cs against the balance of the previous year.) Thus a sum of Rs. 5,43,433/- was therefore available with him to meet out the household expenditure of his family consisting of four members in the financial year 2018-19.

In this connection it is submitted that the officer has already submitted his property statements upto the financial year 2016-17 which has already been seen by Hon'ble Mr. Justice Om Prakash -VII, the then Administrative Judge, Banda in the in the Misc. file of the officer.

The movable and immovable property statement for the financial years 2017-18 and 2018-19 have been submitted by the Officer vide his online case id no. 1178 dated 27.06.2020 which was due to be submitted upto the end of the financial year 2019-20. As such, there is delay in submitting the property statements from the part of the officer.

May, if approved, the movable and immovable property statements for the financial years 2017-18 and 2018-19 of Dr. Suresh Kumar, Chief Judicial Magistrate, Auraiya be laid before Hon'ble Mr. Justice Attau Rahman Masoodi, Administrative Judge, Auraiya Judgeship for His Lordship's kind perusal and orders?
