May kindly see the online 30.06.2020 received from Sri Kailash Kumar, Addl. District and Sessions Judge, Etah regarding submission of statements of movable and immovable properties for the financial years 2017-18 and 2018-19 on proforma to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statements of movable and immovable properties for the financial years 2017-18 and 2018-19 of the Officer concerned, details of income, deductions, savings, investment and expenditure made by him are given below.

1. In the financial year 2017-18, his gross income from salary is Rs. 12,19,397/- and total deductions/Savings/investments against CPF, GIS, Income Tax, loan-repayment, LIC and PPF is Rs. 6,87,758/- (including enhancement of balance of Rs.56,600/- in his saving bank A.cs against the balance of the previous year). Thus a sum of Rs.5,31,639/- was therefore available with him to meet out the household expenditure of his family consisting of three members in the financial year 2017-18.
2. In the financial year 2018-19, his gross income from salary is Rs. 17,86,253/- and total deductions/Savings/investments against CPF, GIS, Income Tax, loan-repayment, LIC and PPF is Rs.10,19,697/- (including enhancement of balance of Rs.1,87,774/- in his saving bank A.cs against the balance of the previous year).. Thus a sum of Rs. 7,66,556/- was therefore available with him to meet out the household expenditure of his family consisting of three members in the financial year 2018-19.

It is pertinent to mention that Smt. Meena Rani, the wife of the officer is an Assistant in School of open learning, University of Delhi whose annual income is Rs.9,05,212/- in the F.Y. 2017-18 and Rs. 7,94,128/- in the F.Y. 2018-19.

In this connection it is submitted that the officer has already submitted his property statements held at the time of entering U.P. Judicial Services which has already been seen by Hon'ble Mr. Justice Rajiv Sharma, the then Administrative Judge, Etah in the Misc. file of the officer.

For the preceding financial years, the officer has submitted his property statements for the F.Y. 2009-10, 2010-11, 2011-12, 2012-13, 2013-14 and 2014-15 which have been processed in offline mode dated 06.10.2020 and separate office note has already been submitted for orders. The officer has submitted his property statements for the financial years 2015-16 and 2016-17 which has been processed in online mode and separate

office note has been submitted for perusal and orders vide application id no. 1185.

The movable and immovable property statement for the financial years 2017-18 and 2018-19 have been submitted by the Officer vide his online application dated 30.06.2020 which was due to be submitted upto the end of the financial year 2019-20. As such, there is delay in submitting the property statements from the part of the officer for which he has stated that due to court work load he could not submit the statement in time and requested to condone the delay.

May, if approved, the movable and immovable property statements for the financial years 2017-18 and 2018-19 of Sri Kailash Kumar, Addl. District and Sessions Judge, Etah be laid before Hon'ble Mr. Justice Anjani Kumar Mishra, Administrative Judge, Etah Judgeship for His Lordship's kind perusal and orders?
